Authorizing Agreement with the New York State Office of Indigent Legal Services (Distribution #8)

By Legislator:
Whereas, In 2003, The State created the Indigent Legal Services Fund to assist counties in providing indigent legal services, primarily through reimbursing payments to attorneys representing indigent defendants, and
Whereas, This funding was contingent on a "maintenance of effort", wherein each county needed to spend at least as much as the prior year to receive it, and
Whereas, In 2010, the State created the Indigent Legal Services Board, which now oversees the fund and in order to receive the maximum amount allowable, the County must enter into an agreement with the Board as it has in past years, and
Whereas, The proposal for "Distribution #8" has been accepted by the Office of Indigent Legal Services, which covers the period January 1, 2018 through December 31, 2020 in the amount of \$388,716 (\$129,572 per year), and an agreement for it must be authorized.
Now, Therefore, Be It Resolved, That Jefferson County enter into an agreement with the New York State Office of Indigent Legal Services for the \$388,716 grant, and that the Chairman of the Board is hereby authorized and directed to execute said agreement on behalf of the County, subject to the review and approval of the County Attorney.
