A motion was duly made by Legislator McBride seconded by Legislator Nabywaniec and there being no discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Montigelli introduced a resolution amending the 2018 County Budget in relation to Samaritan Senior Village, Inc. and entertained a motion for consideration. A motion was duly made by Legislator Drake seconded by Legislator Nabywaniec and there being no discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Montigelli introduced a resolution amending the 2018 County Budget in relation to Recycling & Waste Management and entertained a motion for consideration. A motion was duly made by Legislator Nabywaniec and seconded by Legislator McBride. Legislator Johnson asked if we were only talking about tipping fees and not the possibility of additional fees for recycling with this resolution. Mr. Hagemann confirmed the resolution is just related to the increased revenue and workload the Center is handling. There being no further discussion, the Committee agreed to sponsor the resolution as presented.
