### NOTICE OF ADDENDUM #1

**Please be advised that the following questions have been submitted and answers follow:**

1Q. It appears both of the herbicide application quotes are prevailing wage. The general spec indicates the PRC number is in the detailed specifications. I didn't see it. Could you provide the numbers? We will be able to determine if this is article 8 or article 9 once we have them.

1A. The prevailing wage number is PRC# 2021000131.

2Q. On the top of page 4 (2021-H-10 bid) part of the checklist is Exhibit A – Insurance Certificates (screenshot below) Exhibit A is referenced. Can you confirm the H-10 (sign sheeting / road materials) bid does need to include this Exhibit. If so, can you please provide this Exhibit to us?

2A. No, 2021H-10 does not need insurance.

3Q. I want to make sure we are registered in order to get Addendum information on Bids/RFP, as I do not see Jefferson County as a part of the empire purchase group on BidNet Direct.

3A. If a bid was sent to you, you will get any addendums.

4Q. Is there a deadline for questions to be asked regarding the 2021 Construction and Maintenance Materials Service bids?

4A. Yes, January 25, 2021

5Q. Will any questions asked be published in a Q&A addendum?

5A. Yes, An Email will be sent to potential bidders.

6Q. On the price pages for 2021-H-10 (Page 1 of 6 (21b) Under 1) Reflective sheeting the color "GOLD" is listed. Please advise what the agency is looking for there or if this is an error, as there is no Gold Reflective sheeting that 3M is aware of. Should this be listed in the non-reflective sheeting area?

6A. Delete the line for "Gold" under Reflective for item 1,2,3,4,5.

7Q Due to COVID-19 restrictions on Public Openings for bids, will there be a ZOOM meeting / conference dial in for the Bid opening on Feb. 9, 2021? If not, is it possible to be provided Bid Tabs on responding vendors?

7A. Statement from the Vendor invite Notice dated December 22, 2020 " Please note that due to the COVID-19 related restrictions, there will be no public opening where individuals may be present. However, the opening can be viewed on Google Meet by following this link <https://meet.google.com/dct-xsqm-ngu?hs=122&authuser=2> and once the opening is finished, the recorded version will be posted on our website [www.co.jefferson.ny.us](http://www.co.jefferson.ny.us)".

Yes, everyone that submits a bid will receive a "Notice of Award" and Bid Tabulation with awarded vendor or vendors.

8Q. Does the price of the Bagged Cold Patch in Bid #2021H-2\_Aspphalt Materials on Page 2G need to include freight or should the freight be notated separately?

8A. Price of delivery should be noted separately.
