### RESOLUTION NO. 21-48

## RIGHT-OF- WAY VACATION FOR PORTIONS OF WHITETAIL DRIVE IN GROUSE VALLEY ADDITION PLANNING DEPARTMENT FILE #VS0003-21

WHEREAS, Shawna and Candace Kirk, with Glahe and Associates have filed a petition with Bonner County, Idaho for the vacation (abandonment) of a portion of right of way, Whitetail Drive, located within the Grouse Valley Addition in Section 17, Township 59 North, Range 1 East, Boise Meridian, Bonner County, Idaho; and

WHEREAS, the Bonner County Board of Commissioners held a duly noticed public hearing for the vacation (abandonment) of a portion of right of way, Whitetail Drive, located within the Grouse Valley Addition in Section 17, Township 59 North, Range 1 East, Boise Meridian, Bonner County, Idaho (Planning Department File VS0003-21) on June 09, 2021 pursuant to the procedures of Idaho Code §40-203; and

WHEREAS, following the duly noticed public hearing, the Bonner County Board of Commissioners did adopt findings of fact and conclusions of law in support of the abandonment of a portion of right of way, Whitetail Drive, located within the Grouse Valley Addition in Section 17, Township 59 North, Range 1 East, Boise Meridian, Bonner County, Idaho, concluding that:

- 1.) This proposal is compliant with the vacation criteria and standards set for at Idaho Code §40-203.
- 2.) The abandonment of the easement is in the public interest.
  - a. Finding: The proposed alternate right-of-way does not impact any other neighboring properties adversely. No public agency has objected to the proposed right-of-way vacation. Additionally, there are no utilities located within the areas that are proposed to be vacated, according to the application. Local utility providers were routed as part of agency review, and none responded.
- 3.) By granting this petition for vacation that portion of right of way at the end of Camp Bay Road, located within the South 1/2 of Section 18, Township 56 North, Range 1 East, Boise Meridian, Bonner County, Idaho is beneficial to applicant, the public and the County.
  - a. Finding: The proposed vacation does not leave any real property adjoining the public right-of-way without access to an established public right-of-way as the proposed alternate public right-of-way continues to provide adequate access to all the impacted adjoining real properties.

WHEREAS, the Board of Commissioners, pursuant to the petition dated March 31, 2021 acknowledge that the vacated area is already vested in the petitioner, show of record to be Shawna and Candace Kirk.

**NOW, THEREFORE BE IT RESOLVED** by the Board of County Commissioners, Bonner County, Idaho that a portion of right of way, Whitetail Drive, located within the Grouse Valley Addition in Section 17, Township 59 North, Range 1 East, Boise Meridian, Bonner County, Idaho, described below is hereby vacated.

**BE IT FURTHER RESOLVED** that all easements, franchise rights, appurtenances, or any other interests of any property owner or public utility in or across the property in question shall not be impaired by the granting of the vacation.

**BE IT FURTHER RESOLVED** that Bonner County does hereby grant, deed and convey the vacated right-of-way as described:

ALL that a portion of right of way, Whitetail Drive, located within the Grouse Valley Addition in Section 17, Township 59 North, Range 1 East, Boise Meridian, Bonner County, Idaho, said right-of-way being a strip of land, the centerline of which is generally described as follows:

COMMENCING at the intersection of the south line of said Lot 3 and the east right-of-way of said Whitetail Drive;

A portion of a sixty (60) foot wide public right-of-way known as Whitetail Drive, as shown on the plat of Grouse Valley Addition, as recorded in Book 2 of Plats, Page 100, records of Bonner County, Idaho, over and across a portion of Lots 3, 4, and 5 of Block 2 of said plat of Grouse Valley Addition, being in Section 17, Township 59 North, Range 1 East, Boise Meridian, Bonner County, Idaho, and more particularly described as follows:

Thence leaving said south line and along said east right-of-way, North 33°30'22" East, a distance of 24.82 feet to the TRUE POINT OF BEGINNING;

Thence continuing along said east right-of-way the following three (3) courses:

- 1. Thence North 33°30'22" East, 126.84 feet;
- 2. Thence 180.87 feet along a curve to the left having a radius of 272.36 feet and a delta angle of 38°02'57" (chord North 14°28'53" East, 177.56 feet);
- 3. Thence North 04°32'35" West, 415.81 feet;

Thence leaving said east right-of-way, South 62°24'27" West, 65.21 feet to the west right-of-way of said Whitetail Drive;

Thence along said west right-of-way the following three (3) courses:

- 1. South 04°32'35" East, 390.28 feet;
- 2. Thence 141.02 feet along a curve to the right having a radius of 212.36 feet and a delta angle of 38°02'57" (chord South 14°28'53" West, 138.45 feet);
- 3. Thence South 33°30'22" West, 141.67 feet;

Thence South 70°22'34" East, 61.81 feet to the TRUE POINT OF BEGINNING, encompassing an area of 1.0 Acres more or less.


