

PLATTE COUNTY RESOLUTION #2020-18

RESOLUTION ADOPTING THE FINAL BUDGET FOR FISCAL YEAR 2020 - 2021

WHEREAS, on the 13th day of July 2020, Malcolm Ervin, as Budget Officer for the County of Platte, Wyoming, prepared and submitted to the Board of County Commissioners the budget for the 2020-2021 fiscal year, ending June 30, 2021, and;

WHEREAS, such a budget was duly entered, at large, upon the records of this Board and such a copy thereof was made available for public inspection at the office of the County Clerk, and;

WHEREAS, notice of a public hearing on such budget, together with the summary of said budget, was published in the Platte County Record Times, a legal newspaper published and of general circulation in the County on the 1st and 8th days of July 2020.

WHEREAS, a public hearing was held on such budget, at the time and place specified in said notice, at which time all interested parties were given an opportunity to be heard, and;

WHEREAS, pursuant to W.S. §16-4-111(a) the governing body of Platte County shall adopt a budget to make necessary appropriations within twenty-four (24) hours of said hearing, and;

WHEREAS, also pursuant to W.S. §16-4-106, the amount of estimated revenue from property tax required by the budget shall constitute the basis for determination of the property tax to be levied.

THEREFORE, BE IT RESOLVED, the Platte County Board of County Commissioners hereby adopt the final budget of Platte County for Fiscal Year 2020 – 2021 and justify the necessary amounts to be raised by collection of property tax:




