# HUDSONVILLE CITY COMMISSION City Commission Minutes

October 8, 2019

Mayor Northrup called a Work Session of the Hudsonville City Commission to order on Tuesday, October 8, 2019 at 6:30 PM.

Present: Mayor Northrup, Commissioners Brandsen (6:35pm), Bolhuis, Holtrop, Leerar,

Raterink, Steigenga, City Manager Waterman, City Attorney Wendt, and City

Clerk VanSlyke.

9265. Update on Pickle Ball Project.

Mayor Northrup and City Manager Waterman provided an update on the timeline for a possible pickle ball court installation and current communications with the Hudsonville Pickle Ball Club. The City Commission agreed that Waterman should continue to proceed with the current timeline and the installation of the accessible playground equipment at Hughes Park and the new Parks & Recreation Plan being first priority. The Commission also discussed the need to meet with the pickle ball club to learn their expectations and to create a city policy regarding the use of the courts.

9266. FCC 3<sup>rd</sup> Order Appeal.

Waterman stated that there was a new order from the FCC that would significantly reduce our franchise fees by the value of the communities local peg channel, which can be subjective. There is an appeal against this ruling led by PROTEC, and has been contributed to by the MML Legal Defense Fund. The city has been asked to aide in the costs and be named in the lawsuit. The City Commission was in support of joining the appeal.

9267. Proposed Pedestrian Ordinance and Subsequent Amendment Review.

Waterman reviewed the proposed pedestrian ordinance that would require vehicles to stop for pedestrians in legal crosswalks. The new crosswalk located near Terra Square on Chicago Drive was also discussed. One concern that was mentioned was that this intersection will have yellow flashing lights but vehicles will still be expected to stop for pedestrians, not yield. <sup>1</sup>The crosswalk and the proposed pedestrian ordinance are action items at tonight's City Commission meeting.

9268. Motion by Leerar, seconded by Holtrop, to adjourn the work session at 6:58 p.m. to proceed to the regular session.

Hudsonville City Commission City Commission Work & Regular Session Minutes October 8, 2019

Mayor Northrup called a Regular Session of the Hudsonville City Commission to order on Tuesday, October 8, 2019 at 7:01 PM. The Pledge of Allegiance was stated and Commissioner Holtrop gave the invocation.

## **PUBLIC COMMENTS**

- 9269. Gary VonMyher, 6099 West Bay Ct., Georgetown Township, is an owner of Sonders Eatery and several technology businesses. He expressed his concerns for 5G small cell towers and the possible negative health effects. He asked that the City Commission pass an ordinance that would limit the placement of 5G small cell towers and keep them as far away as possible from homes, schools and day care facilities.
- 9270. Maija Hahn, 2091 Cory Dr., Georgetown Township, is the Director of Michigan for Safe Technology in Ottawa County, and is a representative of small cell technology and making it safe. Her and her colleagues would like to offer to be a resource to the city and the community on 5G technology questions. She asked that the city join PROTEC's coalition that is comprised of communities who are fighting to protect Michigan Rights-of-Ways at the state and federal levels. In addition, Hahn asked that the city pass a resolution for an immediate moratorium on small cell tower installation until it has received further testing and public health has been considered. Material was presented to the City Commission.
- 9271. Amy Kadzban, 4249 Springside Dr., Jamestown Township, presented her concerns regarding 4 & 5G cell towers and the increased risks of cancers that could result from the radiation. Kadzban requested that towers be located further from residential areas, parks and schools.
- 9272. Lisa Bomers, Zeeland resident, voiced her thoughts regarding 5G technology and mentioned many possible health effects and concerns. She asked that the City Commission pass an ordinance that would give the city some control of placement of these towers.
