CTH F Iowa County

The lowa County Highway Department is proposing to recondition CTH F. The project is located in Sections 2, 3, 11, and 14, T04N, R05E, and Sections 27 and 34, T05N, R05E, Town of Moscow, Iowa County, Wisconsin. The project begins at the intersection of CTH F/STH 78 in the Village of Blanchardville and continues northwest approximately 5.0 miles to the intersection of CTH F/STH 39. The project, which is being designed by Jewell Associates Engineers, Inc., will consist of reconstruction and realignment of approximately 0.75 miles of roadway, and reconditioning (pulverize and relay existing pavement) of approximately 4.1 miles of roadway. Sight distance improvements throughout the project limits are being investigated. Culvert pipes/drainage structures will be replaced and drainage/ditching will be improved throughout the project limits. CTH F will be closed to through traffic during construction operations. Construction is currently planned for the 2022 construction season.
