 - 1) Revise item 6 to read: “No residential subdivisions shall be allowed in this category.”
 - 2) Add the following under Rural Development Area: “10. Those parcels currently zoned by Iowa County as Business Districts but located within the Rural Development Area conform to the Land Use Plan.”
 - Amendment of Land Use Map H.1
 - b) Iowa County Comprehensive Plan:
 - Amendment of Section H. Land Use Element Table H.1c – Town of Dodgeville to be consistent with the Town Plan revisions above under item 5. a).
6. Consideration of action by the Town of Dodgeville Plan Commission on proposed amendments to Sections C and H of the Town of Dodgeville Comprehensive Plan as outlined in item 5 above or as otherwise proposed.
 7. Consideration of action by the Iowa County Planning & Zoning Committee on proposed amendments to Section H of the Iowa County Comprehensive Plan as outlined in item 5 above or as otherwise proposed.
