TO THE HONORABLE IOWA COUNTY BOARD OF SUPERVISORS

WHEREAS, the Department's annual preventative maintenance account has been underfunded for over a decade with the Department performing surface treatments to 20+/- miles of County Trunk Highway per year due to budget constraints, when the recommendation for the County's amount of infra-structure is 37 miles per year; and,

WHEREAS, the shortfall of highway improvement funding has led to a backlog of improvement projects, along with the identified culvert repairs; and now the Department is dealing with increased pavement deterioration for surfaces requiring treatments which are not being budgeted due to fiscal constraints and hence are not being performed annually; and,

WHEREAS, the Highway Commissioner recommends immediate surface treatment repairs are necessary to maintain the roadways in a passable condition for motorists along County Trunk Highways, more specifically CTH N and CTH T; and,

WHEREAS, the cost for these immediate pavement surface treatment repairs have been estimated at \$500,000 by the Highway Commissioner; and,

WHEREAS, the Highway Commissioner is requesting funding in excess of the 2021 budget to cover the costs of these repairs so the Department does not have to defer other planned maintenance and construction activities in 2021 from the 2021 budget allocated amounts to cover these costs; and,

WHEREAS, the Public Works Committee recommends to the Iowa County Board to issue financing up to \$500,000 for the Highway Department to perform roadway pavement maintenance repairs in 2021 to maintain asphalt pavement surfaces on County Trunk Highways in the County;

WISCONSIN COUNTIES NEED QUALIFIED WORKERS

WHEREAS, the Iowa County Board of Supervisors has recognized that there is a significant need for a larger talent pool in our region; and

WHEREAS, all rural areas in Wisconsin are struggling to retain their youth and attract families to support open positions; and

WHEREAS, it is generally understood that many former employees left the regional job marketplace when the COVID19 Pandemic started and they did not return; and

WHEREAS, there is a resurgence of job openings in the region that are not being filled, in both the private and public sectors; and

WHEREAS, many employers are leaning on higher wages, retention bonuses, shift differentials, and other incentives to attract job applicants for vacant positions with mixed results; and

WHEREAS, lowa County has many job openings that generally receive very few applications or result in failed searches.

NOW THEREFORE, BE IT RESOLVED by the lowa County Board of Supervisors that lowa County's hereby makes the following request to the Wisconsin State Legislature:

- 1. Since the County's open positions attract very limited applications with many of the applications failing to meet the basic position qualifications. Increasing the education and experience of job seekers is needed. Specifically, lowa County finds that it would be helpful to encourage students to pursue careers in Nursing, Certified Nursing Assistant, CDL driving, and Financial Services. To this end, we encourage the state to consider offering public employment tax breaks, tuition waivers, or scholarship programs.
- 2. County governments, whose budgets are restrained by the levy limit law struggle to compete with private sector entities who offer sign-on bonuses or retention bonuses for new hires. Juggling one department's budget at the expense of another department's puts employee morale at risk and potentially leads to further loss of personnel. Consider, therefore a 2-year exemption to the levy limit law to allow sign-on or retention bonuses when fewer than three applications are received for an open position of the same job title within the same local government entity.
- 3. Consider assisting Wisconsin counties by providing an across the board incentive to employees who work for county government. A limited talent pool can result in the hiring of less productive or less qualified staff, which the State should find undesirable as it directly relies on the services provided by Counties. By offering a tax credit to employees who work for a county government, Wisconsin would be showing support for, and making a commitment to an elevated level of county services, thereby making county employment more attractive to those in the workforce.

BE IT FURTHER RESOLVED that the Iowa County Clerk is hereby directed to transmit a copy of this Resolution to the Governor, Iowa County's Legislative Representatives, and the Wisconsin Counties Association.
