Meeting was called to order by Vice Chair Don Leix at 1:03pm		
Roll Call. Members present: Rod Anding, Ron Benish, Bob Bunker, Kevin Butteris, Dave Gollon, Don Leix, and Dan Nankee. Absent: Jason James Others present: Katie Abbott, Landon Baumgartner		
Approve the agenda for this May 19, 2021 meeting: Sup. Benish made a motion to approve this May 19, 2021 agenda. Mr. Anding seconded the motion. Motion carried.		
Approve the minutes of the April 21, 2021 meeting: Mr. Bunker made a motion to approve the April 21, 2021 minutes. Sup. Nankee seconded the motion. Sup. Leix abstained. Motion carried.		
Report from committee members and an opportunity for members of the audience to address the committee. No action will be taken. Sup. Nankee shared information from an Iowa study on 60-90" row corn yields and biomass, and an article about carbon banking. Mr. Anding shared a report about loss of topsoil and use of no-till. Discussion of conversion of pasture to cropland. Sup. Leix shared the Land Conservation Department's newsletter.		
NRCS update: No update was provided.		
FPP Extension request: Sup. Butteris made a motion to deny the request of Dean Gullickson and issue a notice of non-compliance. Sup. Benish seconded the motion. Motion carried.		
FPP multiple extension guidance: Sup. Nankee made a motion that any FPP participant requesting a second extension must appear before the Committee in person. Mr. Bunker seconded the motion. Motion carried.		
Blackhawk Lake Commission: update, operations agreement, and dam fund resolution draft: The documents were emailed but not received and therefore not on the Commission's agenda. They confirmed receipt of hard copies that were recently delivered, and will have them on the next agenda.		
Farmer Award nominations: the Committee suggested also inviting the 2020 award winners to this year's Farmer's Appreciation Day. Mr. Bunker made a motion to award Bob McCarthy the Conservation Farmer of the Year Award for 2021. Sup. Butteris seconded the motion. Motion carried. Sup. Nankee made a motion to award Len Olson the Friend of Conservation Award for 2021. Sup. Benish seconded the motion. Motion carried. Sup. Benish made a motion to award Mark Steffes the Water Quality and Wildlife Award for 2021. Sup. Leix seconded the motion. Motion carried. Discussion of some farmers' reluctance to be nominated.		

Cost-share project approvals: Sup. Benish made a motion to approve the list of cost-share projects. Sup. Butteris seconded the motion. Motion carried.

Land Conservation Department updates:

- a) **UWEX's Clean Sweep grant for 2022:** Ms. Abbott reported that UW-Extension is applying for a Clean Sweep grant for fall of 2022; Iowa, Lafayette, and Grant Counties will be working together again and each County has pledged cash match for the grant.
- b) **Carbon credits:** Ms. Abbott provided an update and two articles about current carbon credit challenges.
- c) **Conservation Reserve Program:** Ms. Abbott reported about the CRP rate and acreage increases.
- d) **FPP extension fee:** Ms. Abbott relayed information from DATCP about options and challenges with charging additional fees. The Committee asked that Mr. Baumgartner track his time spent on extensions and compliance, and Ms. Abbott will seek advice from Corp. Counsel.

ARTICLE 1 – BACKGROUND AND OBJECTIVES

The purpose of this Memorandum of Understanding (MOU) is to encourage and formalize the cooperative relationship necessary for effective management, coordination and implementation of invasive species programs among the above mentioned Interested Parties.

Various organizations or individuals may, at any time, choose to participate informally with a Cooperative Invasive Species Management Area (CISMA) with a working title of the South-Central Wisconsin Invasive Species Collaboration (SCWISC). These “Informal Participants” will be required to sign a signatory page stating that they will voluntarily participate under the applicable guidelines (or applicable articles) in this MOU or project specific agreement.

Definitions of terms in this agreement are as follows:

- a. “Introduction” means the intentional or unintentional escape, release, dissemination, or placement of a species into an ecosystem as a result of human activity.
- b. “Ecosystem” means the complex of a community of organisms and its environment.
- c. “Native species” means with respect to a particular ecosystem, a species that, other than as a result of an introduction, historically occurred or currently occurs in that ecosystem.
- d. “Non-native species” means with respect to a particular ecosystem, any species, including its seeds, spores, or other biological material capable of propagating that species, which has been introduced to the ecosystem by means of other than natural processes (e.g. human introduction, concurrent introduction with other native or non-native species).
- e. “Invasive species” means a species, typically non-native, that has competitive advantage because of:
 - a. the absence of natural diseases, insects, or other organisms that normally maintain its population in its place of origin;
 - b. the ability to grow earlier and more quickly than native species;
 - c. the ability to reproduce both rapidly and in great numbers; and/or
 - d. the ability to thrive in a wide variety of habitats.

As a result of these competitive advantages, invasive species are able to out-compete and ultimately replace native species and can cause economic or environmental harm or harm to human health.

- f. The area served by the South-Central Wisconsin Invasive Species Collaboration is geographically defined as the lands and waters within the geopolitical boundaries of Sauk, Iowa, Lafayette, Green and Dane Counties.
- g. The South-Central Wisconsin Invasive Species Collaboration Board is made up of both the Interested Parties and Informal Participants.

Invasive, non-native species are recognized as a widespread and increasing problem in southwestern Wisconsin, with serious and detrimental effects occurring on public and private lands and waters. Invasive, non-native species are displacing native communities throughout Sauk, Iowa, Lafayette, Green and Dane Counties.

ARTICLE 2 – LEGISLATIVE AUTHORITY

This MOU is neither a fiscal nor a funds obligating document. Any endeavor involving reimbursement or contribution of funds between the Interested Parties will be handled in accordance with applicable laws, regulations, and procedures including those for Government procurement and printing. Such endeavors will be outlined in separate agreements that shall be made in writing by representatives of the Interested Parties and shall be independently authorized by appropriate statutory authority. This MOU does not provide such authority. Specifically, this MOU does not establish authority for noncompetitive award to the cooperator of any contract or other agreement. Any contract or agreement for training or other services must fully comply with all applicable requirements for competition.

For the Wisconsin Department of Natural Resources, the legal authority for entering into this agreement is Wis. Stats. ss. 23.09 (2)(h), 23.22 (2)(b)3. and 28.07.

ARTICLE 3 – STATEMENT OF WORK

It is the intent of this MOU to enhance the success of an invasive species management program by performing these efforts on all lands and waters, to limit the spread of invasive species. The intent of this MOU is also to enhance the potential for success of a cooperative program in the region by encouraging sharing of resources, information, expertise, and effort on a willing and cooperative basis on both public and private lands and waters. This MOU is not intended to establish legal authorities or mandates where they do not currently exist.

The undersigned Interested Parties mutually agree to the following:

- a. Formally create the South-Central Wisconsin Invasive Species Collaboration CISMA.
- b. Share information among the Interested Parties and provide assistance and expertise regarding invasive species management (e.g. control methods, introduction prevention measures, restoration tools, standardized data collection, etc.) activities on their lands and waters.
- c. Provide opportunities to outside interest groups, private landowners, and the public for involvement in carrying out invasive species management planning on lands and waters within the SCWISC management area.
- d. Utilize the Upper Sugar River Watershed Association as the fiscal administrator for any grants or financial support received by South-Central Wisconsin Invasive Species Collaboration.
- e. Review this MOU and request revisions and updates as necessary to meet the purpose of this agreement. Amendments shall become effective upon approval by all Interested Parties. This includes adopting a new name approved by the Board.

This MOU in no way restricts any of the Interested Parties from participating in similar activities with other public or private agencies, organizations, or individuals.

ARTICLE 4 – TERM OF AGREEMENT

This MOU will expire five years from the signature of the first renewed partner, at which time it will be again subject to review, renewal or expiration. If the partners mutually agree to continue cooperation, a new agreement shall be executed.

ARTICLE 5 – MODIFICATION AND TERMINATION

Modifications within the scope of this MOU shall be made by the issuance of an unanimously approved modification prior to any changes being performed. Any Interested Party may withdraw from this agreement at any time before the date of expiration by providing 30 days written notice to all signatories.

ARTICLE 6 – ADDITIONAL PARTIES TO THE MOU

Additional parties may, and are encouraged to, be added to the MOU at any time. All signatories will be notified by the South-Central Wisconsin Invasive Species Collaboration steering committee of any additional party and will be given 30 days after the notification to determine if there is a conflict of interest. If a conflict of interest is identified, the signatory may choose to withdraw from the MOU. If the signatory does not choose to withdraw, then the additional party with the conflict of interest may not be added to the MOU.

ARTICLE 7 – REPORTS AND/OR OTHER DELIVERABLES

There are no reports and/or other deliverables associated with this MOU.

ARTICLE 8 – PROPERTY UTILIZATION

There is no property utilized in association with this MOU.

ARTICLE 9 – STANDARD CLAUSES

- a. Nondiscrimination: The Interested Parties shall comply with all Federal statutes relating to nondiscrimination and all applicable requirements of all other Federal laws, Executive orders, regulations, and policies. These include but are not limited to: (a) Title VI of the Civil Rights Act of 1964 (42 U.S.C. 2000d, 2000e-16), which prohibits discrimination on the basis of race, color, disability, or national origin; (b) Title IX of the Education amendments of 1972, as amended (20 U.S.C. 1681-1683, and 1685-1686), which prohibits discrimination on the basis of sex; and Section 504 of the Rehabilitation Act of 1973 as amended (29 U.S.C. 794) which prohibits discrimination on the basis of disabilities. A nondiscrimination statement shall be posted in offices of the Interested Parties and on all materials that are produced by the Interested Parties for public information, public education, or public distribution.

- b. Indian Preference: Notwithstanding section a above, Tribal government parties to this MOU, including inter-tribal agencies, will apply Indian preference consistent with each agency's policies and the federal Indian Self Determination & Education Assistance Act.
- c. Promotions: None of the Interested Parties will publicize or otherwise circulate promotional material associated with activities undertaken pursuant to this MOU that states or implies endorsement of a product, service or position which the other Interested Parties represent.
- d. Publications of Results and Studies: None of the Interested Parties will unilaterally publish a joint publication associated with activities undertaken pursuant to this MOU without consulting the other Interested Parties. This restriction does not apply to popular publications of previously published technical matters. Publication pursuant to this MOU may be produced independently or in collaboration with others. However, in all cases, proper credit will be given to the efforts of those parties contributing to the publication. In the event no agreement is reached concerning the manner of publication or interpretation of results, either Interested Party may publish data after due notice and submission of the proposed manuscripts to the other Interested Parties. In such instances, the Interested Parties publishing the data will give due credit to the cooperation but assume full responsibility for any statements on which there is a difference of opinion.
- e. Indemnification: Each party shall be responsible for its own acts and the results thereof, and shall not be responsible for the acts of the other party and the results thereof. Each party, therefore, agrees that, with respect to the other parties, it will assume all risk and liability to itself, its agents or employees, for any injury to persons or property resulting in any manner from the conduct of its own operations, and the operation of its agents or employees under this contract, for any loss, cost, damage, or expense resulting at any time from any and all causes due to any act or acts, negligence, or by the failure to exercise proper precautions, of or by itself or its own agents or its own employees, while occupying or visiting the premises under and pursuant to this contract. Nothing in this agreement shall be interpreted to authorize or obligate any party or any employee of such party to operate outside the scope of employment of such employee, and no party shall be required to indemnify another party.
- f. Debarment and Suspension: The Cooperator shall immediately inform the Forest Service if they or any of their principals are presently excluded, debarred, or suspended from entering into covered transactions with the Federal Government according to the terms of 2 CFR Part 180. Additionally, should the Cooperator or any of their principals receive a transmittal letter or other official Federal notice of debarment or suspension, they shall notify the Forest Service without undue delay. This applies whether the exclusion, debarment, or suspension is voluntary or involuntary.

- g. Notices: Any communications affecting the operations covered by this agreement given by the Forest Service or the South-Central Wisconsin Invasive Species Collaboration is sufficient only if in writing and delivered in person, mailed, or transmitted electronically by e-mail or fax, as follows:
 - 1. To the Forest Service Program Manager, at the address specified in the MOU.
 - 2. To the Cooperators, at the address shown in the MOU.Notices are effective when delivered in accordance with this provision, or on the effective date of the notice, whichever is later.
- h. Text Messaging While Driving: In accordance with Executive Order (EO) 13513, "Federal Leadership on Reducing Text Messaging While Driving," any and all text messaging by Federal employees is banned: a) while driving a Government owned vehicle (GOV) or driving a privately owned vehicle (POV) while on official Government business; or b) using any electronic equipment supplied by the Government when driving any vehicle at any time. All Cooperatives, their Employees, Volunteers, and Contractors are encouraged to adopt and enforce policies that ban text messaging when driving company owned, leased or rented vehicles, POVs or GOVs when driving while on official Government business or when performing any work for or on behalf of the Government.
- i. This MOU is not a legally binding agreement and creates no legally binding obligations for any party. However, it does express the intent of the parties regarding the work they will undertake for this collaboration and their representative roles in the collaboration.

ARTICLE 10 – KEY OFFICIALS AND SIGNATURES

A separate sheet will be included for each of the Interested Parties designating the key official to this MOU and the signature of the person authorized to enter into this agreement.
