Re: Public comments received on proposed "lowa County Bloomfield Prairie Ordinance"

From WI Department of Natural Resources: Wardens Joseph Frost and Alan Erickson

Section IV, A., 16.: suggested edits for clarity

Trapping and hunting practices inconsistent with Wisconsin regulations and:

- Use of <u>any</u> traps not placed completely under water unless the traps are other than enclosed trigger or cable restraint traps
- b) Placement of traps within 50 feet of mowed areas.
- c) Setting, placing or checking traps between the hours of 11pm and 5am on the following day
- d) Setting or placing traps within 100 yards of the pond
- e) Setting or placing traps within 300 yards of the Bloomfield Health and Rehabilitation Center buildings
- f) Use of any traps outside of water other than a cable restraint trap.
- Consider allowing trapping of muskrats within 100 yards of the pond using colony traps only.

<u>From Peter Vanderloo:</u> representing the Iowa County Recreation and Prairie Restoration, Ltd. (current Lessee)

- Consider consistency with the use of the terms "prairie" or "farm" versus using both.
- #15 under Section IV, A "Prohibited Uses": "Prohibitions IV 15 is still troubling. I clearly
 understand the safety issue, and if on the committee I would vote to protect the county for
 liability. However I support language to permit public use when livestock are not present."
