RESOLUTION TO CREATE TWO PROJECT BASED PUBLIC HEALTH NURSE POSITIONS.

#### THE HONORABLE IOWA COUNTY BOARD OF SUPERVISORS:

WHEREAS, local and tribal health departments in Wisconsin have received federal funding under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) to help with Coronavirus pandemic testing, planning and contacting tracing; and

WHEREAS, the purpose of this funding is to support local efforts towards the shared mission of stopping the spread of the virus with the "Box It In" strategy of Testing, Isolation, Contact Tracing, and Quarantine; and

WHEREAS, the Iowa County Health Department requests two full-time Public Health Nurse Project positions to assist with the "Box It In" strategy and the ongoing Coronavirus pandemic; and

WHEREAS, given the uncertainty of state and federal funding, the position is considered a project funded position through September 2021 and will be evaluated for extension in August 2021.

**NOW THEREFORE, BE IT RESOLVED,** by the Iowa County Board of Supervisors that the two full-time Public Health Nurse Project positions be added to the Iowa County Health Department as soon as possible upon approval of this Resolution.

**BE IT FURTHER RESOLVED,** that the funding for these project position will be paid by federal and state grant as approved and appropriated in the Iowa County Health Department Budget.
