

Roll Call: Highway Commissioner Hardy; Sheriff Peterson; Trace Frost, Law Enforcement Liaison; Joe Thomas, Ridgeway Town Chair; Sup. Meyers; Briant Russell, State Patrol. Absent: Joe Davis, WisDOT/BOT; Troy Maggied, SWWRPC; Excused: Iowa County Corp Council and Health Department Director; Austin Durst and Michael Havlik Sheriff's Department... Also Present on Zoom: Charlene Schmid, WisDOT Traffic Engineer; Greg Lee, Dodgeville Public Works; Logan Prochaska, SWTC Driver's Education. Agenda for this 02-14-2023 meeting and minutes of the 11-08-2022 meeting were approved by 3 unanimous consent with no revisions. No Comments from the Public. Review listing of Representation. A copy of the contact information was distributed to all attendees/members of the commission with the meeting packets. Hardy requested members review their 4 contact information and advise him of any revisions. Hardy provided an update that speed limit zones had been revised on CTH HHH near the Village of Ridgeway and CTH F near the Village of Blanchardville. The speed limit on CTH HHH was raised from 45MPH to 55MPH between the CTH HHH overpass and the roundabout. The speed limit was raised in the village to remove the 30MPH zones and replace them with either 35MPH or 25MPH as signed. On CTH F, within the village limits; the speed limit was changed from 25MPH to 35MPH. In addition, a request was made of Charlene to evaluate the speed limit between the old and new CTH F intersection locations along STH 78. Hardy summarized the construction projects occurring in Iowa County in 2023 being the following: A. STH 133 Lone Rock Bridge Closure June 2023. B. STH 39 Mill and Overlay – Mineral Point to STH 18 C. STH 80 Mill and Overlay - Cobb to Highland D. CTH K USH 18/151 - CTH ID Barneveld E. CTH W Bridge Replacement / Closure – Jonesdale 6 F. CTH H – HN42 Bridge Replacement / Closure at Knobs Road G. CTH T Barneveld Wood Street - CTH H? H. CTH Q STH 18 – STH 80 M-F Daily Closures April – June. I. ATC Powerline Utility Permit – USH 18/151 lane closures thru November 2023. J. Invenergy Solar Farm – Cobb Area completion early Fall 2023.

Trace went over other topics for crash data and the spot report maps. Discussion of the green lighting legislation and the limitation of being for municipal vehicles only. Reviewed the spot maps,

Discussion of issues with the ATC line installation regarding use of temporary traffic control devices and leaving them up when no one is working or around; nights and weekends. Discussion of timber mat locations to avoid them being hit by passing vehicles. Discussed permitting process and the Highway shop would followup with ATC site superintendent / project manager; regarding placement and coverage of non-relevant TTC signage.
