10	Iowa County District Attorney's Report: Iowa County District Attorney Zachary Leigh presented a report that was attached to the agenda. The report included caseload information and legal updates.
11	Iowa County Child Support Office Report: Wendy Doescher discussed the 2022 Annual Report that was completed by Director Deb Rosenthal before her retirement.
12	Sheriff's Department Update/Report: Sheriff Peterson gave an update reference the issues with cell providers and the number of 911 hang ups. Sheriff Peterson gave information reference call volume, and that the Sheriff's Office has handled 1,000+ more calls than this point last year. Sheriff Peterson praised Deputy Michael Havlik's work with the DARE program. Warden Alan Erickson, Avoca Police Chief Chad Kanable, and Dispatcher Keith Drury were recognized for their work on an EMS call in the Avoca Area.

Public Safety Committee – Emergency Management Report for June & July 2023 Activities.

Emergency Management has been working on the Integrated Preparedness Plan as required by the State for 2024. Presentations to the Local Emergency Planning Committee and the Iowa County Emergency Services Association were held. Data derived from a six-county survey was reviewed and discussions were had about what areas of focus we should have for the next 4 years. Work will continue on this plan for the next few months.

ICEM facilitated the development of drills for the Iowa County Circuit Court. On Friday, July 14, ICEM facilitated those drills with courtroom staff, Security Personnel, Jail Personnel, District Attorney Office Personnel, and 22 volunteers who played parts as jury members or persons in the gallery. An After Action Review is in progress and will be presented to the court when finished.

The School Safety and Security Team continues to meet with school districts to discuss Safety & Security plans and work toward the development of a countywide basic plan for all districts. Additional planning for Active Shooter/Mass Attack school staff training is also in progress.

Monthly meetings continue with the Health Department. We meet to maintain information flow and working relationship between the two departments.
