| 3 | Approve agenda for November 14, 2023. Peterson moved to approve, seconded by Leigh. Approved unanimously. |
| 4 | Approve minutes from CJCC meeting held May 23, 2023. Leigh moved to approve, seconded by Peterson. Approved unanimously. |
| 5 | Report from committee members and an opportunity for members of the audience to address the committee. No action will be taken. No reports given. |
| 6 | Report on Iowa County Drug and OWI treatment courts. <ul style="list-style-type: none">- Current court progress: six current participants in drug treatment court with one recent graduation, one pending expulsion, and three pending referrals; two current participants in OWI court with one pending referral- Treatment provider tours and out-of-county options: treatment court team toured Rogers Behavioral, 5-Door Recovery, and Miramont Behavioral treatment facilities in Madison. Rogers offers intensive outpatient treatment options, 5-Door provides residential care, and Miramont provides acute psychiatric care- Treatment Coordinator's Conference: conference provided helpful information that was well-presented, including on transgender participants and testing policies- Recidivism statistics: coordinator shared OWI and treatment court recidivism statistics (included in agenda packet)- Events: Recovery Cookout saw fair attendance; Brats 'N Boats was minimally attended, due in part to poor weather; Massey presentation had sold 250 tickets. Important to continue providing sober community event opportunities: possible future events include bowling or ice skating, and may be able to coordinate with other organizations (e.g. Lions, Kiwanis, or Women's Club)- Drug testing service provided for social services by treatment court coordinator and Sheriff is providing positive interactions with treatment court team members and is financially advantageous to Iowa County |
| 7 | Approval of letter of support for 2024 TAD Grant application. Peterson moved to approve, seconded by King. Approved unanimously. |
| 8 | Approval of Drug Treatment Court handbook revisions. Changes for handbook were proposed, including amendments to roles/responsibilities, readmission to treatment court, ignition interlock devices, |

	and travel requests. Leigh moved to approve, seconded by King. Approved unanimously.
9	Consideration of scheduling a community mapping exercise. Community mapping exercise could be done to identify community resources and gaps in those resources. Discussion regarding potential invitees to participate in the exercise and potential facilitators. Look to schedule in early 2024.
10	Committee vacancies. Discussion of multiple vacancies on CJCC and potential candidates to fill those vacancies.
11	Set next meeting date and agenda items. Next meeting scheduled for 5:00 p.m. on January 18, 2024.
