Meeting was called to order by Chair Gollon at 1:00 pm

Approve the agenda for this February 28, 2024 meeting: Sup. Butteris made a motion to approve this February 28, 2024 agenda. Sup. Leix seconded the motion. Motion carried.

Approve the minutes of the January 24, 2024 meeting: Mr. Bunker made a motion to approve the January 24, 2024 minutes. Sup. Geisking seconded the motion. Motion carried.

Report from committee members and an opportunity for members of the audience to address the committee. No action will be taken. none

Introduce new LCD staff- Sara Wilhelm: Ms. Wilhelm introduced herself.

NRCS update: None provided

Blackhawk Lake Commission update: Sup. Leix reported that the commission discussed progress on the shower house, and future projects.

Wildlife Damage Abatement program (Zac Venchus): Approve 2023 Wildlife Damage Claims: Sup. Leix moved to approve the claims. Sup. Butteris seconded the motion. Discussion of harvest objectives. Motion carried.

Bloomfield property listening sessions and survey results; discussion and approval of next steps: Ms. Abbott presented a summary of the public input process and results. Discussion of County-owned public land, ag use, protection options, costs and funding. Sup. Kreul made a motion for staff to continue looking at funding and management options. Sup. Geisking seconded the motion. Motion carried.

Cost-share project approval: Ms. Abbott presented the project list and an email from a concerned CCA about non-payment of NMP services. Discussion of if/how we can check that CCAs are getting paid. Staff would need to ask DATCP what we are allowed to do. Sup. Kruel made a motion to table until next meeting. Sup. Butteris seconded the motion. Motion carried.

Birch Lake repair updates; discussion and approval of next steps: Ms. Abbott gave an update on options for a variance for the DNR grant bidding timeline. Sup. Leix made a motion to rebid the two excavation projects in 2024, and bid out the valve repair in 2025. Mr. Vanderloo seconded the motion. Motion carried.

Land Conservation Department updates:

- A) Annual report: Ms. Abbott presented the Department's 2023 report
- B) 10-yr Land and Water Resource Management Plan- due Dec 2025: Iowa County's LWRM Plan is due for a full update in 2025. This is a long process that will get started in late 2024.

Iowa County Conservation Awards descriptions and criteria:

Award winners should demonstrate a conservation ethic and good stewardship that goes above and beyond and serves as an example in the County.

- *Iowa County Conservation Farmer of the Year*: This award must be given to an active farmer, preferable one who derives most of his/her income from farming, who shows consistent, outstanding conservation work. This includes comprehensive practices throughout the farm to reduce soil erosion, promote healthy soil, protect water quality, and manage nutrients. Preference is for farmers who are also active in promoting conservation through volunteering, field days, or otherwise influencing peers to follow their example.
- Water and Wildlife Steward: Landowners or farmers who improve and/or protect water quality and/or create a haven for wildlife on their property. Nominees may also be organizations that provide exemplary work in managing water resources or habitat, assisting landowners, and/or providing outreach and education. Citizens who show impressive dedication to Iowa County water quality through volunteering or education may also be considered. Habitat can be game or non-game, with a preference for declining species and a diversity of habitat types or species benefitted.
- *Friend of Conservation*: A professional, teacher, business, elected official, etc. who has shown dedication to conservation, beyond the duties of his/her job, through education, outreach, technical assistance, volunteering, or other efforts.
- *Iowa County Tree Farmer of the Year*: Chosen by DNR. Landowners who manage timber on their properties in a sustainable way, implementing a forestry plan and BMPs.

Land Conservation Department 2024 Work Plan summary

Long-term Goal 1: Facilitate farmer/landowner investment in conservation practices

Strategy 1a: Address financial and technical barriers to conservation implementation

- Continue cost-share programs for nutrient management plans, no-till, cover crops, and structural practices (site visits, contracting, designs/permits/as-builts, payments, reimbursements, tracking, reporting, Phosphorus and nitrogen reduction calculations)
 - o Contract engineered and agronomic projects to spend \$90,000 in cost-share funds
 - o 1-2 projects installed using phosphorus Multi-discharger Variance funds
- Continue Nutrient Management Planning training for farmers
 - o 2 classroom sessions and 3-5 update sessions
 - o Create new page on website with NMP information (advantages, trainings, links, etc)
- Assist municipalities with phosphorus trading programs as feasible
 - o 3-5 baseline NMPs created, assist with site visits as time allows
- Explore no-till drill needs and avenues to increase access to rentable drills
 - Look at grant opportunities
 - o Discuss rental arrangements with implement dealers
- Promote new cost-sharable practices when/if ATCP50 changes are approved
- Look for ways to streamline program processes (e.g., online payments/form submittal)
- Influence statewide policies and programs
 - o Participate in Land+Water Association Legislative Committee meetings
 - Testify in hearings or submit comments on legislation pertaining to County conservation programs or funding
- Participate in Lowery Creek Watershed Initiative and Southern Driftless Grasslands partnership
- Participate in WI Grazing Coalition meetings and projects
 - o Assist with practitioner survey to assess technical assistance coverage and gaps
- Provide non-cost-shared technical assistance/advice as requested/feasible

Strategy 1b: Provide incentives for conservation practices

- Continue Farmland Preservation tax credit program
 - ~170 site visits with follow-up letters and database entry
 - o Review NMPs as they are submitted and enter into database (~200)
 - o Complete self-certification process for all FPP participants (~675; mailing, payment processing, data entry, reminders, reports)
 - o Send compliance reminders as needed
 - Summer soil testing reminder letters
- Continue Conservation Reserve Enhancement Program partnership
 - o 10-15 agreements, payments, transfers/revision paperwork, reporting
 - o Complete ~6 easement visits with DATCP
- Use enforcement tools when necessary
 - o Review manure storage permit applications and send Certificates of Use
 - o Respond to complaints and manure spills; send NR151 noncompliance letters if needed

Long-term Goal 2: Facilitate a culture of conservation in the farm community

Strategy 2a: Increase frequency and variety of conservation messages for farmers and landowners

- Continue use of Facebook, e-news, print newsletters, videos, and newspaper articles
- Partner on fields days, webinars, or other outreach: 1-2 Uplands Farmer-led field day(s), 1-3 Lowery Creek Watershed Initiative events, 2-3 Southern Driftless Grasslands bird-friendly farming programs, 1-2 local pasture walks

Strategy 2b: Increase awareness/understanding of conservation standards, practices, and programs by ag businesses and consultants

- Continue to build relationships with ag retailers, agronomists, lenders, etc
 - o Annual update (via email) for agronomists; notify of events or new programs as needed

Strategy 2c: Engage area youth in conservation education

- Continue annual Youth Conservation Field Day (approx. 150 kids- plan/implement with UWEX)
- Continue poster contest
- Present at River Valley high school field day at Cates Farm

Strategy 2d: Recognize farmers for their efforts

- Continue conservation award program (four awards presented)
- Explore other recognition program and funding needs
 - o Partner with Uplands Watershed group on farm signs and conservation driving tour

Long-term Goal 3: Reduce well and groundwater contamination

- Continue groundwater quality cost-share program (using ATC funding)
- Partner with Iowa Co Health Department on Groundwater Awareness Week
 - o Create 2 videos; organize one presentation/webinar on groundwater quality
- Continue participation in Land + Water conservation-public health committee

Other activities

Promote wildlife/habitat and recreation practices

- Continue working with County team and local partners on Bloomfield Property management and planning
- Assist with recreation projects/grant program (using ATC funds)
- Partner on poison hemlock education/ID; attend South Central Invasives Partnership meetings
- Provide wildlife habitat/invasive species information online and upon request

Maintain County-owned dams

- Complete inspections, mowing, and regular debris removal on all dams
- Explore camera availability for outlet pipe internal inspections
- Continue Birch Lake dam repairs and Municipal Dam Grant/permit requirements

Maintain office tracking and record keeping

- Continue use/maintenance of GIS shapefiles and four databases for program/practice tracking
- Track staff time for grant and program reporting (CREP, MDV)
