Meeting was called to order by Chair Gollon at 1:00 pm

Roll Call. Members present: Bob Bunker, Kevin Butteris, Roger Geisking, Dave Gollon, Darrell Kreul, Don Leix. Excused: Peter Vanderloo. Others present: Katie Abbott, Monica Yates-Olsen, Sara Wilhelm, Tom Michek

Approve the agenda for this March 27, 2024 meeting: Sup. Leix made a motion to approve this March 27, 2024 agenda. Mr. Bunker seconded the motion. Motion carried.

Approve the minutes of the February 28, 2024 meeting: Sup. Butteris made a motion to approve the February 28, 2024 minutes. Sup. Kreul seconded the motion. Motion carried.

Report from committee members and an opportunity for members of the audience to address the committee. No action will be taken. Sup. Kreul mentioned a field day at Pioneer Farm regarding cover crops, soil loss, and water quality.

Introduction of Monica Yates-Olsen, new Farm Service Agency County Executive Director: Ms. Yates-Olsen introduced herself and provided an FSA update.

NRCS update: None provided.

Blackhawk Lake Commission update: Mr. Michek provided an update: the beach wall was completed with funding from Iowa County's tourism grant. Shower house project is moving forward; they are working to bring it up to ADA standards.

Cost-share project approvals: Ms. Abbott provided information on upcoming cost-share projects. Sup. Leix made a motion to approve the projects. Sup. Butteris seconded the motion. Motion carried. Sup. Leix made a motion to require an invoice or statement before paying on projects (including cover crops and NMPs). Sup. Kreul seconded the motion. Motion carried.

Farmland Preservation Program Notices of Noncompliance:

Sup. Kreul made a motion to issue an immediate NON for Jerry Zander. Mr. Bunker seconded the motion. Sup. Leix moved to amend the motion to issue a NON if a 10ft buffer is not installed in two months. Sup. Butteris seconded the motion. Motion to amend carried. Amended motion carried.

Farmer Appreciation Day award nominations: Ms. Abbott provided the nomination forms and requested nominations by May 13.

Land Conservation Department updates:

- **D) SWIGG Continuing research**: The SWIGG study researchers received grant funding to continue research based on the previous well water samples, related to health risk, factors correlated to pathogen contamination, and presence of antibiotic resistant genes.

What conservation practices does this farmer use? Provide specific examples.

Jim Campbell runs a diversified organic dairy operation in Rewey, WI and ships milk to Organic Valley Coop. Jim participates in a specific program through Organic Valley which nearly eliminates row crops in his feed rations. Jim's farm is almost entirely in perennial cover of some sort and he has embraced rotational grazing and silvopasture with some recent investments in access roads along with paddock fencing.

How has this farmer promoted healthier soil, groundwater, and/or surface water to other farmers or the community? Please provide some concrete examples.

Although I am not aware of specific local organizations he works through to promote agriculture to others in Iowa County, he is a willing speaker, as displayed by the youtube video below put together by a partner of the USDA Organic label. https://www.youtube.com/watch?v=VWru6lusF_A

Jim has the next generation helping out on the farm last I checked, and has passed on some land to his son and daughter in law so they are able to gain equity in the farm and keep their mission going. Even as an organic operator, Jim's rotational soil loss can stand up to any no-tiller out there and is always curious and seeking new ways to improve, it seems no matter how long he is farming.

Rotational Grazing, stream crossing, roofed barnyard, no-till, nutrient management plan

How has this farmer promoted healthier soil, groundwater, and/or surface water to other farmers or the community? Please provide some concrete examples.

This family converted many acres of previously tilled ground to rotational grazing. This allows much more water infiltration and less erosion. They have abandoned barnyard(s) that used to drain directly to the stream. They moved the barnyard to higher ground and created a roofed area for winter confined feeding so that there would be much less potential for nutrient runoff to the stream on the property. They are always open to telling their story or hosting field days, and have a sheep grazing field day planned for June.

John and Pam actively participate in steam bank erosion control work through NRCS EQIP program to lesson downstream sedimentation in Otter Creek watershed. They also included habitat structures to increase food for trout and other fish species, rock structures to increase riffles and dissolved oxygen levels, and backwater refuges to provide wetland habitat.

They also maintain a mesic prairie with unique plants and a woodlot using forestry best management practices. They are enrolled in the Managed Forrest Law program.
