| 6 | Report on Iowa County Drug and OWI treatment courts. Current court progress: six current participants in drug treatment court with two pending referrals; three current participants in OWI court with zero pending referrals but two individuals as potential referrals. The 2024 TAD grant application was approved, and Melissa Peterson will be taking over as project director (TAD guidelines require that a county employee hold that role). Review of Drug and OWI court annual reports: reports were included in the agenda packet. Upcoming training opportunities: Sheriff Peterson is scheduled to attend the WATCP strategic planning meeting in March, and excellent speakers are lined up for the WATCP annual conference in April. The treatment court team will be attending both that conference and the AllRise national conference in May, with attendance at the national conference funded by opioid settlement grant funding approved by the HHS Committee. |
