Roll Call: Highway Commissioner Hardy; Sheriff Peterson; Deputy Schauff; Todd Horn, Law Enforcement Liaison; Joe Thomas, Ridgeway Town Chair; Mitch Schauf Iowa County Deputy; Chris Wells WisDOT Traffic Engineer; Dave Gress – WisDOT – BOTS; Austin Coppernoll, SWWRPC; Sup. Consent Agenda for this 08-13-2024 meeting, the minutes of the 05-14-2024 meeting, and the dates for the 2024 commission meetings were motioned for approval by Thomas, seconded by Peterson. Motion approved unanimously. The Remaining Meeting dates for 2024 were approved as: 1) Tuesday November 12, 2024 at 9:30AM. Those future meetings will be held in Room 101 of the Law Enforcement Center on Leffler street. Report from Committee Members and Public Comment. No action taken. No comments.

5	 Highway department Project updates: A. Curve warning Signage Project – Hardy stated the department was updating the curve signage in the county. In addition, Hardy stated some chevron signage has been back ordered and will be installed at locations as defined based on the >MPH criteria across the county. Upon receipt the department would complete the project affecting some 1200+ signs across the county. B. Small Bridge Program – The Department had completed inventory of all structures in the county. In all the Couty had about 342+/- of the small bridge structures identified. The County ended up owning 131 V-# structures, with 208 belonging to the townships and 3 to the Village of Barneveld. The inspection process would be starting later this fall with completion earmarked by December of 2025. C. Update of the work occurring on CTH T between Barneveld and CTH H, which will be under construction thru December of 2024. The Trail portion of the project was yet to be let with construction to occur in fall 2024 and completion in 2025. D. Update on a Box Culvert replacement on CTH H south of Ridgeway near the Amble Farm, which would close CTH H south of Ridgeway for a period of 34 weeks.
6 & 7	BOTs Report and Spot Map Report. Todd Horn provided a PowerPoint slide deck of several items. The slide deck was emailed to all attendees after the meeting and included with the meeting minutes in the county file archives. Spot Map Report – in the 2 nd quarter of 2024 May-July there were 82 crashes reported resulting in 1 fatalities and 27 injuries. We reviewed a data summary of crash data by driver behavior, crash types, and zone heat maps for the occupant protection and aggressive flags. Also, we reviewed a heat map based on the months of June-August and frequency of occurrences issues. The slide deck included a summary of two incidents: one on USH 151 north of CTH YD and one on STH 130 at the STH 133 bridge location. Lastly, we looked at some updates and information available thru Community Map, including training videos, Pavement Friction, and other topics.
