Call to order. Meeting called to order by Matt Allen at 5:02 p.m. 1 Roll call. Members present: Matt Allen, Curt Johnson, Bruce Paull, Mike Peterson, Jennifer King (joined at 5:15); 2 Members not present: Ryan Bohnsack, Zach Leigh Others present: Mel Masters Approve agenda for October 21, 2024. Johnson moved to approve, seconded by Paull. Approved 3 unanimously. Approve minutes from CJCC meeting held August 29, 2024. Paull moved to approve, seconded by 4 Johnson. Approved unanimously. Report from committee members and an opportunity for members of the audience to address the committee. No action will be taken. 5 No reports given. Report on Iowa County Drug and OWI treatment courts. Current court progress: eight active participants in drug treatment court; three active participants in OWI court. 2025 TAD grant application for drug treatment court: non-competitive grant year application will be for the same amount of grant funding as in 2024 (\$75,046 in grant funds from the State with 25% county match). * Approve letter of support for grant application: Motion by Johnson to approve draft letter, 6 seconded by King. Approved unanimously. Opioid settlement funding: at the October 2, 2024, HHS meeting, the treatment court program was awarded \$10,000 in opioid settlement funds Discontinuation of OWI treatment court in 2025: due to budget cuts in Iowa County, the OWI treatment court program will be discontinued in 2025. We will continue to explore alternative funding and pretrial/hybrid court options to address the OWI/alcohol use disorder population. The drug treatment court program will continue to be funded. Community mapping exercise. Judge Allen reviewed results of the community mapping exercise held on September 5, 2024, which was attended by 15 individuals from multiple local agencies. Information gathered during 7 the exercise will be collated and distributed. It was noted that SWCAP is planning a community listening session on rural mental health (tentative date of 11/16) and that the Ridgeway Public Library has a workstation available for public use. **Set next meeting date and agenda items.** Next meeting scheduled for 5:00 p.m. on January 16, 2025. 8 **Adjournment.** King moved to adjourn, seconded by Johnson. Approved unanimously.
