Meeting was called to order by Vice Chair Leix at 1:05 p.m.

Roll Call. Members present: Bob Bunker, Kevin Butteris, Darrell Kreul, Don Leix, Dan Nankee, and Peter Vanderloo. Excused: Dave Gollon Others present: Katie Abbott, Sara Wilhelm

Approve the agenda for this April 30, 2025 meeting: Mr. Vanderloo made a motion to approve the April 30, 2025 agenda. Sup. Kruel seconded the motion. Motion carried.

Approve the minutes of the March 26, 2025 meeting: Sup. Kruel made a motion to approve the March 26, 2025 minutes. Mr. Bunker seconded the motion. Motion carried.

Report from committee members and an opportunity for members of the audience to address the committee. No action will be taken. Mr. Bunker shared an article about the Cates family farm from the Progressive Forage magazine, and asked about ways to track or calculate wind erosion. Sup. Nankee asked about county dam funding.

Dam fish barrier agreement: Mr. Bunker made a motion to approve the agreement. Sup. Kruel seconded the motion. Motion carried.

Land Conservation Department updates: Ms. Abbott provided the following updates.

- a) Dam updates: Jewell Engineering will be hired for required inspections and possible benchmarks. Birch Lake repairs are moving forward, and Ms. Abbott is working with staff to source signage regarding the new ordinance language.
- **b) State budget advocacy information:** Ms. Abbott provided a memo with information on representative contacts and talking points.

May 22 Restoring and Protecting Aldebaran Farm

Aldebaran Farm has a fascinating history: both Frank Lloyd Wright and Svetlana Stalin lived there for brief periods. The current owners completed a conservation easement with the Driftless Area Land Conservancy (DALC) last year and their son recently bought adjacent land. They will touch on the property's history, then walk us through their process and their prairie as they describe restoring and protecting the 17-acre homestead. June 26 Bats Bouncing Back: Updates on the Surface and Subterranean

Wisconsin is home to more than 40% of the nation's little brown bats! Four of the state's eight bat species continue to experience stress from White-nose Syndrome (WNS), but there is some good news to share. Join us to learn about local bats, citizen monitoring, WNS research in WI, and how you can help. Big brown bats and tricolored bats that hibernate on the Taliesin property have been monitored for 10 years. We will offer a tour of underground sites after the indoor presentation. Stick around after sunset to observe, count, and listen to bats emerging from summer roosts. This event will be from 6:30-8:30 pm.

July 24 Be a Good Ancestor - Build Good Soil

Whether you tend a farm, a garden, or a yard, this wisdom from Native American ecologist Robin Wall Kimmerer should be taken to heart. Nurturing soil health has benefits far beyond your piece of ground, and far into the future. Soil experts will use soil cores, a rainfall simulator, and a trip to a perennial crop field and blueberry patch to describe interactions between soil health, water quality and movement, and plant life. Learn the basics of carbon sequestration, taking and interpreting soil tests, creating healthy soil, and soil-stream dynamics.

Experience the nocturnal world under dark, starry skies and learn how to conserve them. Light pollution threatens not only our "right to starlight", but can affect energy consumption, wildlife, and health. Discover how you can become a citizen-scientist by identifying familiar constellations and measuring night sky brightness (with a phone app) through the Globe at Night campaign. The Lowery Creek Watershed Initiative believes in the power of community when it comes to conserving our natural and agricultural resources long-term. We work together to keep farmland in farming; protect and manage agricultural, natural, and cultural resources; use science to guide us; and grow community around conservation.

Our watershed, or drainage basin, runs from the Lower Wisconsin River south to Pleasant Ridge, six miles as the crow flies. It is a small watershed packed with a Class I trout stream that hosts a rare heritage population of brook trout, a UNESCO World Heritage Site (Frank Lloyd Wright's Taliesin estate), a Ramsar Wetland of International Importance (the Lower Wisconsin State Riverway), and landowners who are creating a promising future for our land, water, and economy.

Individually and together, we are working to promote Driftless-friendly values and practices in and around our watershed.
