Library Planning Committee Tuesday, May 29th at 2 p.m.

The meeting was called to order by Chair Dan Nankee at 2:01 p.m.

Roll Call. Members present: Dan Nankee, Judy Lindholm, Barbara Polizzi and Vickie Stangel. Others present included Mark Storti, Southwest Wisconsin Library System Board and Larry Bierkee, County Administrator. Excused Absent: Linda Gard and Alex LeClaire.

Lindholm moved, Polizzi seconded to approve the May 29, 2018 agenda. Motion carried unanimously.

Approval of the May 10, 2018 meeting minutes. Nankee opened matter for discussion. Nankee corrected Mark Storti's position to be representing the Southwest Wisconsin Library System Board. Amended motion approved unanimously.

Reports: Burkee reported the amount of the lowa County Library Levy was \$325,307. Storti reported the next SWLS Board meeting will be held on July 11, 2018 at 5:30 P.m. at the SWLS Headquarters.

Draft lowa County Library Plan: Committee reviewed recent suggestions by Polizzi to LeClaire's modified plan. Stangel and Polizzi will collaborate to put committee revisions into document and send to committee for review. Statistics from public libraries partly located in lowa County will be added to appendix.

Goals and Objectives: Committee reviewed usage by other counties funding above 70% and how monies were allocated. Committee discussed need for marketing campaign for lowa County Libraries as a whole. Many suggestions for future collaborations among libraries were discussed. Committee members will continue to think about the objectives and goals that should be included in the next Library Plan.
