Members present: Linda Pittz, Tom Forbes, Bruce Paull, Tom Howard, Joan 2 Davis, Sue Steudel, and Judy Lindholm. Others present: Dr. Peter Mullin, Medical Advisor; Kelley Syse (Student Nurse/observer); and Sue Matye, Director/Health Officer Approve the agenda for this September 19, 2018 meeting: Lindholm moved to approve the agenda: 3 Paull seconded the motion. Motion carried. Approval of the minutes from the August 22, 2018 prior meeting: Davis moved to approve the 4 minutes of the June 6, 2018 meeting. Forbes seconded the motion. Motion carried. Report from Committee members and an opportunity for members of the audience to address the 5 Committee. No comments. 2018-2022 Strategic Plan: Director Matye distributed copies of the 2018-2012 Strategic Plan and 6 discussed several revisions to the initial draft that addressed specific programs. Environmental Health Program Update: Town of Pulaski Property: Director Matye gave a brief presentation of the history and recent developments related to the clean-up of this property, including before/after pictures. She explained that little improvement was shown in the June pictures but considerable improvement was evident in the November pictures. She explained the process of resolving this case, including referrals to Unified, the assessment that was completed, that the resident had moved 7 to a nursing home and that the resident's relatives had done considerable cleaning at the property. She stated that Sanitarian Troy Moris has "signed of" on the property and that the case was now considered closed. Director Matye reported that there were no updates on the Mineral Point case or with the Dodgeville "Fentanyl" case. Other Program Updates: 2018 Wellness Expo is scheduled for Friday September 28. Flu shots will be available at the Wellness Expo. 8 The Health Department is starting to schedule school flu clinics. The Health Department will be holding interviews shortly for LTE's; 1 or 2 applicants have applied so Monthly Report: Director Matye distributed copies of the Monthly report. Nothing reported out of the 9 ordinary. (Fluoride pills are no longer available). **Next meeting date:** To be announced.
