1	Call to order. Vice - Chair Meek called the January 7, 2019 Long Range Planning Committee meeting to order at 3:00 p.m.
2	Present at roll call: Jeremy Meek, Doug Richter, Bruce Haag, and Mark Storti. Absent: James Griffiths Others present: Larry Bierke, Craig Hardy, John Meyers, Steve Deal, and Don Leix
3	Approve the Agenda for this January 7, 2019 meeting. Motion by Sup. Richter seconded by Sup. Haag to approve the January 7, 2019 Long Range Planning Committee agenda. Motion Carried.
4	Approve the Minutes of the August 21, 2018 meeting. Motion by Sup. Storti seconded by Sup. Haag to approve the Long Range Planning Committee August 21, 2018 minutes. Motion Carried.
5	Report from committee members and an opportunity for members of the audience to address the Committee. No action will be taken. Meyers noted that the committee should be discussing the potential disposition of property should a new jail and nursing home be built.
6	Discussion of 10, 15, and 20 year plan: The Committee discussed both the Jail Building and the lot it is located on. It was decided that reselling the lot would have accessibility challenges for vehicular traffic. The Committee decided that it made more sense to combine the jail lot with the Highway Department lots. This would make rebuilding in phases easier when a new County Shop was needed. Storti moved, Richter seconded that the Sheriff's Office and Jail parcel will be combined with the Highway Department after the building is vacated. Motion carried. The Committee further discussed adding a courtroom to the proposed jail building and decided it would be a good idea to have the City of Dodgeville representatives at the next Long Range Planning Committee Meeting. Storti moved, Haag seconded to ask if the City of Dodgeville representatives could attend the next Long Range Planning Committee meeting. Motion carried.
7	Set next meeting date. Storti moved, Haag seconded to set the next meeting was set for February 4 th at 3:30 pm. Motion carried.
8	Adjournment. Motion by Sup. Storti seconded by Sup. Haag to adjourn at 4:18 p.m. Motion Carried.
