3	Davis moved, Meek seconded to approve the January 21, 2019 Agenda. Motion carried at 5:01 p.m.
4	Anderson moved, Ehr seconded to approve the minutes of the December 10, 2018 meeting. Motion carried at 5:01 p.m.
5	Reports: Paula Schoenberg with Family Advocates is interested in programming space in a new facility.
