## DEPARTMENT UPDATE TO HHS COMMITTEE 6 Mar 2019

- 1. CVSO has been named as a facilitator of the Iowa County Veterans and First Responders Community Group. The group meets at 8 a.m. on the third Thursday of every month at Cobblestone Coffee House in Dodgeville. The group has been slow to start with only a couple members attending, it is hoped that the location and time change will bring more participants. The original location and time were 9:00 a.m. at Upland Hills Health center.
- 2. Spring edition of office newsletter has been distributed. Winter edition totaled 945 copies mailed to county veterans.
- 3. The United States Federal Circuit Court of Appeals rendered a favorable court opinion for "blue water" Vietnam Navy veterans. At issue was, in 1991, Congress passed the Agent Orange Act, granting a presumption of service connection for certain diseases to veterans who "served in the Republic of Vietnam". In 1993, the Department of Veterans Affairs issued regulations that stated "service in the Republic of Vietnam includes service in the waters off-shore and service in other locations if the conditions of service involved duty or visitation in the Republic of Vietnam". A 1997 General Counsel opinion about a different regulation resulted in the government limiting service "in the Republic of Vietnam" to only those service members that had duty or visited on the landmass or inland waterways of Vietnam. This rule is generally referred to as "boots on the ground".

This court opinion (Procopio v. Wilkie) states that the definition of "in the Republic of Vietnam" should use the internationally accepted definition of countries, which includes the territorial waters, which is a strip of water 12 nautical miles out from the land edge of the country. This change, depending on the outcome of appeals if any would extend presumptive service connection for conditions such as type 2 diabetes, cardiac issues, lung cancer and others to Navy veterans that served off shore of Vietnam.
