| 6 | Future Plans with the City of Dodgeville: The Committee discussed the idea of including the City of Dodgeville Police Department in the new Law Enforcement Center. The Committee asked Bierke questions about the use of evidence storage space for City/Village local police departments. Bierke wasn't sure, but noted that if asked, the County would likely store their evidence.  DeVoss was asked if the City had any interest in sharing space at the Jail. DeVoss noted that the City was planning to establish a committee to consider options, but that he felt the City and County was likely on different timelines and that combining into one building may not work out. He was later asked if the City would be interested in locating in the County Courthouse and using some vacant space there. DeVoss and Bierke will tour the Courthouse after the City of Dodgeville establishes a committee.  Bierke also noted that the Land Conservation Department lease was up for renewal in 2020. He is evaluating the current options.  Storti moved that the Jail Building Committee include a space for a courtroom, seconded by Richter. Meyers noted that he preferred a building expansion option to add another building onto the lot for the Courtroom. Griffths noted that he was concerned that the County couldn't afford it. Haag moved to amend the motion to consider a possible expansion for a second floor for a courtroom space with office Storti seconded. Motion carried 4-1 with Sup. Griffiths voting Nay.
