- 1 The meeting was called to order at 9:31 AM by Chair Hardy.

- Agenda for this 02-19-2019 meeting and minutes of the 11-13-2018 meeting were approved by unanimous consent with no revisions.
- 4 Report from committee members or the general public: None.
- Chair Hardy went over the ATV/UTV route recommendations from Town of Brigham, Town of Highland, Town of Pulaski, and Town of Mifflin. A listing of these recommendations can be found on page 11 of the meeting packet. There was general discussion amongst the Commission regarding revised route recommendations and the revised proposed route maps. Thomas Forbes moved to recommend review of ATV route requests to the Public Works Committee Sue Matye seconded. Approved unanimously.
- Chair Hardy gave an overview of the 2019 Workzone Safety Week April 8th to the 12th resolution Draft.

 There will be a kickoff April 8th at the Dane County Highway Department with state Government officials attending.
- Frost provided the BOTS summary. State of Wisconsin had a total of 55 fatalities in 2019 which is down from 75 the same time last year. Iowa county had a total of 3 fatalities in 2018, which was about average. Frost updated the Commission of the Governor's Conference scheduled for August 20-22, 2019 at the Wilderness Resort in WI Dells.
- Spot map reports and review. Schmidt summarized the accident/incident history of the last quarter for the commission. From October to December 2018 Iowa county had a total of 148 crashes with 1 fatality in October. 7 serious injury crashes with 3 being alcohol related and 4 distractive driving. In 2019 there has been a total of 73 winter related crashes reported on 18/151 with a total of 6 on the new 52 & 54 overpass.
