- 1 The meeting was called to order at 9:31 AM by Chair Hardy.
- Roll Call: Highway Commissioner Hardy; Austin Durst & Mike Havlik, Sheriff's Dept; Briant Russell, State Patrol; ; Greg Lee, City of Dodgeville DPW; Joe Thomas, Town of Ridgeway; Ryan Mayer, WisDOT Traffic; Trace Frost, Law Enforcement Liaison;
  - Absent: Iowa County Corp Counsel; Joe Davis, WisDOT BOTS; Randy Wiessinger, Law Enforcement Liasion; Thomas Forbes, County Board Supervisor; Kristina Tranel, SWWRPC; Sue Matye, Iowa County Health Department; Annette Biggin, SWTC Driver's Education;
- Agenda for this 11-12-2019 meeting and minutes of the 08-13-2019 meeting were approved by unanimous consent with no revisions.
- 4 Report from committee members or the general public: None.

Review ATV Routes as requested by the respective ATV/UTV Clubs:

# A. Towns of Arena and Brigham requests - Wildlife Forever ATV Club

- 1) CTY HH at intersection of H and HH from the Town of Arena Border to Knight Hollow Rd
- 2) CTY HH south of Arena from Ridgeview Rd to AACC
- 3) CTY H south of arena at the intersection of Mellum Rd to Roberts Rd
- 4) CTY K south of Barneveld from Prairie Grove Rd to Urness Rd
- 5) CTY K south of Arena from Zwettler Rd to Sweeny Rd
- 6) CTY K south of Arena from Roelke Rd to Frame Rd
- 7) CTY K south of Arena from Knight Hollow Rd to the intersection of CTY KK
- 8) County KK at intersection of CTY K to Reeve Rd

**Concerns:** Poor intersection visibility at the following locations: Intersections of CTH H and HH in Arena Township, CTH H and K in Brigham Township.

Motion made by Duerst, seconded by Lee. Motion to recommend for approval proposed Routes 2, 5, and 6; Durst to review route proposals 3 and 4 with a recommendation to be provided to the Public Works committee meeting on 12/02/2019; Duerst to Review Route 3 in the field along with the Township recommended route on Dugway, Pikes Peak, CTH T, and Mill road as the township may repeal that route if CTH H from Hyde to CTH Y is provided by the County. Furthermore, Duerst to review the intersection of CTH H and Amacher Hollow Road to consider that as an extension of the route from Mellum Road in Route 3. Recommendation to not recommend Routes 7 or 8 until Dane County or the townships of Black Earth or Vernon adopt atv/utv routes, as riders cannot go into Dane County at this time. Motion to not recommend Route #1 due to visibility concerns and accident history at the intersection of CTH H and CTH HH. Motion carried unanimously.



## B. Town of Ridgeway to Hyde request - Pec Valley ATVers

- 1) CTY HHH to the roundabout at CTY BB
- 2) CTH HHH to Ridgeview Road
- 3) CTY Y from Ridgeview Road to CTH H
- 4) CTY T from Pikes peak Road to Mill Rd.
- 5) CTH BB from the Roundabout at CTH HHH to STH 191 to Tom's Campground.

Concerns: The Town of Ridgeway met with the Pec Valley club and discussed options to get from Ridgeway to Hyde. The township approved a route consisting of Dugway, Pikes Peak, and Mill Roads. The Wildlife Forever Club would like to discuss utilizing CTH H all the way to CTH Y in lieu of ending in Hyde on CTH H. Discussion over the original intent of the ordinance was to use county roads as connectors to township routes not as primary routes. The township chair indicated if the county were to open CTH H, the township may repeal Dugway, Pikes Peak, and Mill roads. Request to add routes to:

- 6) CTH H from the terminus in Hyde to CTH Y, petition submitted by residents on CTH H.
- 7) CTH ZZ from CTH Y to CTH Z to Pleasant Ridge.

Motion made by Duerst, seconded by Lee. Motion to recommend route requests 1, 2, 3, ad 4 as the preferred option from the township to Hyde. Duerst to review option 6 CTH H from Hyde to CTH Y prior to the Public Works committee meeting on 12/02/2019 and make a recommendation regarding 6 versus 1 thru 4. Hardy to discuss the option #5 of WisDOT allowing a route along STH 191 from CTH BB to Spring Road allowing access to Tom's Campground. Route #5 to be brought back by the committee upon response form WisDOT regarding the potential to utilize STH 191 from CTH BB to Spring Road. Route option #7 to be brought back to the committee until the clubs discuss atv/utv routes with the township of Dodgeville, at which point the commission could reconsider in February of 2020. Motion carried unanimously.

# C. Townships of Mineral Point and Waldwick - Pointer Prowlers ATV Club

- 1) CTH YD from STH 23/Business Park Road to CTH D.
- 2) CTH Y from Governor Dodge Rd in Mineral Point township.
- 3) CTH S from County Line Rd to CTH W in Waldwick township.
- 4) CTH O from BUS 151 to the Iowa/Lafayette county line.
- 5) CTH S Rock Branch Rd to CTH D in Mineral Point township.
- 6) CTH DD in Mineral Point township to CTH D.
- 7) CTH DDD from CTH DD to CTH W.
- 8) CTH A in Mineral Point Township.

Concerns: Some discussion of the speed limit on Business 151,as well as which portions were in the City of Mineral Point versus the Township, and whether the road was the state's or not. Bus 151 carries a 45 MPH speed limit from the city limit to CTH O, which may require WisDOT approval to become a route. Mayer stated the state has reviewed the speed limit and is not opposed to the township lowering the speed limit to 35 MPH by resolution, at which point the town could adopt BUS 151 as a route without WisDOT approval per statute. Discussion of other potential access points and routes:

- 9) CTH D form CTH S to STH 39.
- 10) CTH W from Lafayette County Line to CTH DDD in Waldwick.
- 11) CTH DD from CTH D to CTH DDD.
- 12) CTH YD from CTH D to USH 23/151.

**Motion** made by Duerst and seconded by Mayer. Motion to recommend atv routes for: 1, 3, 5, 6, 7, 9, 10, and 11. Motion carried unanimously. The clubs to discuss CTH Y and ATV/UTV routes with the Township of Dodgeville. The club to discuss with the Township of Mineral Point to pass a resolution to lower the speed limit along BUS 151 to 35 MPH, then to adopt BUS 151 in the town as an ATV/UTV route in their ordinance. The County would then review CTH O as an ATV/UTV route to connect with Lafayette County. Routes #2, 4, and 8 to be brought back to committee in February after further



discussion and action between the clubs and the townships of Dodgeville and Mineral Point. Discussion of Route #12 which was proposed as a crossing point for atv/utv traffic at 151. Commission delayed discussion for another alternative along STH 39 later in the meeting. Motion carried unanimously.

## D. Town of Linden, Mifflin and Mineral Point - Southwest Wisconsin ATV Club

There is interest in getting a route from the village of Linden - Cobb area to connect with the City of Mineral Point. Club requests routes on

- 1) CTH B from Sunny Slope Rd to Bloomfield Rd (1.5 mi)
- 2) CTH Q from Bloomfield Rd to CTH QQ (1 mi)
- 3) CTH QQ South/East from Q to STH 39 (2.5 mi)
- 4) STH 39 from CTH QQ to City of Mineral Point Fountain St. (1 mi) via the state bridge statute exclusion.
- 5) CTH E from Mifflin east to Log Town Road.

Concerns: Hardy stated he had talked with WisDOT and the proposed route along STH 39 between CTH QQ and Fair Street would be allowed per the statute exclusion. This would provide a safer solution for crossing USH 151 than using CTH YD; and with access to CTH Q and Bloomfield Road would connect the township routes with Mineral Point.

**Motion** by Duerst, second by Russell to recommend routes 1 through 4 into the city of Mineral Point. The club to discuss adoption of STH 39 by the city and township for statute compliance. Duerst to review the CTH E portion from Log Town Road to Mifflin with the club and make a recommendation for the 12/02/2019 public works committee meeting. Motion carried unanimously.

# E. Town of Eden, Highland and Pulaski - Ridge Runners of Iowa-Grant ATV/UTV Club

- 1) <u>Pulaski Township</u>: CTH P from Old 80 Rd to existing route that connects Dry Dog Rd and Hickory Flat Rd.
- 2) Highland Township: CTH I from Tower Rd to existing route at Smokey Hollow Rd.
- 3) CTH I from existing route at Steil Rd to Grant County Line (If not to Grant County line, would like to Dry Bone Rd from existing at Steil Rd).
- 4) Eden Township: CTH J from existing routes at CTH B to Cave Hollow RD/Hwy 18 (Route to extend across 18 to Cave Hollow Rd and onward to Plank Rd.

Concerns: Hardy stated CTH I along the Grant County line is actually maintained by Iowa County through various agreements. It would make sense to allow use of CTH I to Montfort to connect the various roads in Highland township and Grant County. Discussion of crossing STH 18 at Cave Road. STH crossings are allowed without permits as they are an extension of the connecting road routes. Motion by Thomas and seconded by Duerst, to recommend passage of all requested routes. Motion carried unanimously.

# F. Town of Eden – Eden Township and Badger Solar Farm

The Eden Town Clerk stated the Town Board has decided to open Vickerman and Drinkwater roads for ATV use at their recent meeting. The township was requesting the roads surrounding the Badger Solar Farm project to be opened as well to allow use of atv/utvs for the project.

- 1) CTH B from CTH G to CTH XX
- 2) CTH XX from CTH B to CTH X
- 3) CTH X from CTH XX to CTH G
- 4) CTH IG from CTH XX to CTH G
- 5) CTH G from Roaster Road to CTH X.

**Concerns:** The request is to utilize the routes for the Solar farm project, although once opened will be difficult to close as atv/utv routes. The conversation was with the Town of Eden and the Solar farm, but some roads are in Mifflin township. The Solar Farm project is anticipated to be under construction from 2019-2022.

Motion by Duerst and second by Thomas to postpone further discussion until the Township of Mifflin weighs in on being in support of the use for the solar farm project. Highway Commissioner to discuss with the township, and bring back in February. Thank you from Travis Disch and Diane Halverson to Craig Hardy and the Iowa County Board for their work with the ATV routes. Hardy explained several atv/utv ordinances were approved, amended, and adopted for the following Cities, Townships and Villages in the County: A. Village of Cobb B. Village of Linden C. City of Mineral Point 6 D. Township of Eden E. Township of Mineral Point F. Township of Ridgeway G. Township of Waldwick Frost provided the BOTS summary. State of Wisconsin had a total of 490 fatalities to-date in 2019; which is down from 576 the same time last year and 594 in 2017. 7 Spot map reports and review. Mike Havlik summarized the accident/incident history of the last quarter for the commission. Iowa county had a total of 111 crashes excluding deer hits from August to November 12, 2019, zero fatalities, 33 injured (8 in work zone). DOT trying to complete the Hwy 18/151 project but the weather has made it difficult. Here are the options provided: 1) Open all lanes and let people go; 2) Keep one lane until spring. Austin reported on the Traffic Safety Grant (\$20,000 from Grant-Wise) which will be set up for on a 4hour block of time on a Sunday afternoon for seat belt check, and for OWI a 10-2 shift from Thursday through the weekend will be set up. There will be voluntary immobilization over Christmas. Hardy commented a proposed bill was being reviewed and circulated by the Legislative Reference Bureau. Greg Lee had sent Hardy a Draft notice for this bill (no # assigned to it yet). The bill proposes changes to how atv/utv routes are designated and under new bill, all roads will be ATV routes unless individual municipalities say otherwise. Other business for discussion. Hardy summarized there are 13 culverts to repave and one to replace. No 9 other new business. Meeting adjourned at 11:17 AM by unanimous consent. Next meeting date will be on Tuesday, February 11, 2020 at 9:30 A.M. in the Community Room of the Health & Human Services building in Dodgeville. Routes to be reviewed/discussed for the February TSC Meeting:

- 1. Towns of Arena and Brigham Wildlife Forever ATV Club.
  - a. CTH K from Knight Hollow Road to CTH KK
  - b. CTH KK from CTH K to the Dane County Line.

Action needed before February meeting: ATV Club to discuss route adoption with Dane County and the Townships in Dane County being Black Earth and Vernon. No action by the Commission until routes in Dane County are an option for a connection. Club shall notify Highway Commissioner at least 10 days in advance of the Traffic Safety meeting for placement on the agenda.

- 2. Towns of Dodgeville and Ridgeway Pec Valley ATVers.
  - a. CTH ZZ from CTH Y to CTH Z (Pleasant Ridge Store access).
  - b. STH 191 from CTH BB to Spring Road (Tom's Campground access).

Action needed before February meeting: Club to discuss adoption of STH 191 with the Town of Ridgeway and they must include in their ordinance. County to review STH 191 upon concurrence from township, then apply for sign permit and plan from WisDOT. Club must discuss and receive concurrence for the use of CTH ZZ with the Town of Dodgeville as an access to Pleasant Ridge store.

- 3. Towns of Dodgeville and Mineral Point and the City of Mineral Point Pointer Prowlers ATV Club
  - a. CTH Y in Mineral Point Township discuss CTH Y with the Town of Dodgeville and where the route would go to?
  - b. BUS 151 in the Town and City of Mineral Point
  - c. CTH O from BUS 151 to Lafayette County
  - d. CTH A from USH 151 to the Mifflin township line.

Action needed before February meeting: Club to discuss adoption of routes within the Town of Dodgeville with the township before consideration of CTH Y, but recommend to not be a dead-end route. Club to discuss BUS 151 with the City and Town of Mineral Point. Both must include BUS 151 in their jurisdictions as an atv/utv route by the 35MPH exclusion clause. The township shall adopt a resolution to set the speed limit on BUS 151 in the town at a 35 MPH. A copy of the resolution would go to the state; a which point the state would sign accordingly. Then BUS 151 could become an atv/utv route if in the ordinances of the city, town, and county with no further WisDOT approvals. A sign permit and plan wou be required and prepared by WisDOT, at which point the county would sign the route. If BUS 151 is opened per the above requirements, the county would revisit the CTH O request. Club to define their request for the use of CTH A start and end points; as the commission has concerns with traffic getting to USH 151 from CTH A.

- 4. Town and City of Mineral Point Southwest Wisconsin ATV Club
  - a. STH 39 from CTH QQ to Fair Street in the City of Mineral Point.
  - b. STH 39 from CTH QQ to the City of Mineral Point in the Town of Mineral Point.

Action needed before February meeting: Club to work with the city and township to have STH 39 included as a route within their respective ordinances including the state highway bridge exclusionary rout adoption language. Upon revision of their ordinances, the commission could do likewise to allow use of the STH 39 corridor from CTH QQ to the city and send that request to WisDOT for a sign permit and plan

- 5. Town of Mifflin Badger Solar Farm and Southwest ATV Club.
  - a. CTH B from CTH G to CTH XX
  - b. CTH XX from CTH B to CTH X
  - c. CTH X from CTH XX to CTH G
  - d. CTH IG from CTH XX to CTH G
  - e. CTH G from Roaster Road to CTH X.
  - f. Sponsored for use by the Badger Hollow Solar Farm project. An ATV/UTV club would have to sponsor after the project completion date.

**Action needed before February meeting:** Club to request the use of the roads by the solar farm and other with the township of Mifflin. The Club must be willing to assume route sponsorship after completion of the solar farm project.

#### Ordinance No. 600.18B

# IOWA COUNTY ALL-TERRAIN and UTILITY TERRAIN VEHICLE ROUTE ORDINANCE

#### **SECTION 1.0: INTRODUCTION**

#### 1.1 NAME

This Ordinance shall be called the Iowa County All-Terrain and Utility-Terrain Vehicle Route Ordinance.

#### 1.2 INTENT

Following due consideration of the recreational and economic value to connect trail opportunities and weighted against possible dangers, public health, liability aspects, terrain involved, traffic density and history of automobile traffic, this ordinance has been created pursuant to County Board authority under Wis. Stat. §§ 59.02, 23.33(4)(d)3.b., 23.33(11)(a) and (am), and 23.33(8)(b) as amended.

#### 1.3 DEFINITIONS

- A. <u>All-Terrain Vehicle ("ATV")</u> has the meaning specified within Wis. Stat. § 340.01 (2g).
- B. <u>ATV/UTV Route</u> shall mean a highway or sidewalk designated for use by all-terrain and utility-terrain vehicle operators by the governmental entity having jurisdiction.
- C. <u>Utility-Terrain Vehicle ("UTV")</u> has the meaning specified within Wis. Stat. § 23.33 (1), (ng).

#### 1.4 SEVERABILITY

The provisions of this Ordinance shall be deemed severable and it is expressly declared that Iowa County would have passed the other provisions of this Ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this Ordinance or the application to any person or circumstance is held invalid, the remainder of this Ordinance and the application of such provisions to other persons and circumstances shall not be deemed affected.

#### 1.5 SAVING CLAUSE

This Ordinance shall in no way be deemed to supplant or otherwise invalidate any provision of state statutes relating to the subject matter hereof. Any person entrusted with the enforcement of this Ordinance may, in the exercise of his or her discretion, proceed under applicable state statutes.

#### SECTION 2.0: ATV/UTV ROUTES AND OPERATION

#### 2.1 DESIGNATION

All requests for new or revised ATV/UTV route designations shall first be submitted to the lewa-County Traffic Safety Commission for review at its November quarterly meeting. The lewa-County Traffic Safety Commission shall review such requests for county trunk highway route designations and make a recommendation to the lewa-County Public Works Committee. The Public Works Committee shall review designation of ATV/UTV routes, including appropriate criteria for making a designation, and make a recommendation to the lewa-County Beard of Supervisors. County highways designated as ATV/UTV routes shall be approved by the lewa-County Beard of Supervisors by amendment of Sec. 2.4 of this Ordinance.

A copy of ATV/UTV routes, along with a map showing their location, shall be kept on file at the Highway Department. The lowa County Highway Department shall file ATV/UTV routes adopted by this Ordinance with the Department of Natural Resources Conservation Warden for Iowa County and with the Madison, Wisconsin, Office of the Wisconsin Department of Natural Resources. The Iowa County Highway Commissioner shall have the authority to temporarily close or terminate any ATV/UTV route enacted by this Ordinance for a period up to ninety (90) days. Closures for duration of greater than ninety (90) days shall be reviewed by the Public Works Committee.

#### 2.2 RULES OF OPERATION

- A. All ATV/UTVs shall operate only on the paved portion of the roadway. Operation on the gravel shoulders, grassy in-slope, ditches, or other highway right-of-way area is prohibited and illegal.
- B. No ATV/UTV shall be operated at a speed greater than 30 miles per hour (MPH), or the posted speed limit, whichever is lower.
- C. No ATV/UTV may be operated on any designated route between the hours of 1:00 AM and 5:00 AM daily.
- D. All ATV/UTV operators shall ride in single file on the extreme right hand side of the paved portion of the highway except that left turns may be made from any part of the roadway which is safe given prevailing conditions.
- E. All ATV/UTV operators shall have their headlight and taillight illuminated, while operating on a county highway.
- F. Except as otherwise authorized by State law, all operators
  - a. of ATV's who are at least 12 years of age and who are born on or after January 1, 1988 shall possess a valid state-issued ATV Safety Certification.
  - b. of ATV's between the age of 12 and 15 must be accompanied by a parent or

legal guardian or a person at least 18 years of age who is designated by the parent or guardian at all times when operating on a roadway designated as an ATV route or when operating on roadways of highways that are ATV trails.

- c. of UTV's must be 16 years of age or older.
- d. of UTV's who are at least 16 years of age and who are born on or after January 1, 1988 must possess a valid state-issued Safety Certificate.
- e. of ATV/UTV's and their passengers under 18 years old shall wear protective headgear while operating on route-designated county highways.
- G. Mandatory Use of Seatbelts during Operation of a UTV. ALL occupants riding in, or operating a UTV, shall be required to wear a seatbelt when travelling on any trail or route within lowa County.
- H. Possession of Open Intoxicants in an ATV or UTV while in Operation. It shall be unlawful for any person to possess any bottle or receptacle containing alcohol beverages if the bottle or receptacle has been opened, the seal has been broken, or the contents of the receptacle have been partially removed, while operating or as a passenger on an ATV or UTV on any road or road route in lowa County.
- I. ATV/UTV operation shall be subject to all provisions of WI Stats. § 23.33, which is adopted as a part of this ordinance by reference.

#### 2.3 SIGNAGE OF ATV ROUTES

- A. Routes shall be marked with uniform all-terrain vehicle route signs in accordance with s. NR 64.12(7), Wisconsin Administrative Code. No person may do any of the following in regard to signs marking ATV/UTV routes:
  - Intentionally remove, damage, deface, move, or obstruct any uniform ATV/UTV route or trail sign or standard or intentionally interfere with the effective operation of any uniform ATV/UTV route or trail sign.
  - 2) Possess any uniform ATV/UTV route or trail sign or standard of the type established by the department for the warning, instruction or information of the public, unless he or she obtained the uniform ATV/UTV route or trail sign or standard in a lawful manner. Possession of a uniform ATV/UTV route or trail sign or standard creates a rebuttable presumption of illegal possession.
- B. All required designated route signs shall be paid for by an ATV/UTV club, with approval, installation, and maintenance of the signs by the Iowa County Highway Department.
- C. The quantity and location of signage shall be reviewed and approved by the lowa County Highway Commissioner, where appropriate, placed at the beginning of an allterrain vehicle route within the county and at such locations and intervals deemed necessary to enable the ATV/UTV operators to follow the route.



- D. No sign may be mounted on any existing County sign post or telephone post/pole.

  Posts shall be suitably sized for mounting the necessary amount of signs at the location
- E. No person shall operate an ATV/UTV contrary to any authorized and official posted sign.

#### 2.4 DESIGNATION OF ROUTES

All requests for new or revised ATV/UTV route designations shall first be submitted to the lowa County Traffic Safety Commission for review at its November quarterly meeting. The lowa County Traffic Safety Commission shall review such requests for county trunk highway route designations and make a recommendation to the lowa County Public Works Committee. The Public Works Committee shall review designation of ATV/UTV routes, including appropriate criteria for making a designation, and make a recommendation to the lowa County Board of Supervisors. County highways designated as ATV/UTV routes shall be approved by the lowa County Board of Supervisors by amendment of Sec. 2.4 of this Ordinance.

A copy of ATV/UTV routes, along with a map showing their location, shall be kept on file at the Highway Department. The lowa County Highway Department shall file ATV/UTV routes adopted by this Ordinance with the Department of Natural Resources Conservation Warden for lowa County and with the Madison, Wisconsin, Office of the Wisconsin Department of Natural Resources. The lowa County Highway Commissioner shall have the authority to temporarily close or terminate any ATV/UTV route enacted by this Ordinance for a period up to ninety (90) days. Closures for duration of greater than ninety (90) days shall be reviewed by the Public Works Committee.

The General intent for the use of County Trunk Highways for atv/utv's by designation into this Ordinance is for County Trunk Highway Road Routes to provide connections between township road routes, to provide access or connection of villages to the various road routes when no other options exist, and not to serve as primary road routes for recreation. County Trunk Highways are classified into four categories based on their significance or importance of usage. Those categories are Principal Arterial, Major Collector, Minor Collector, and Local Road. Highways categorized as Principal Arterial and Major Collector primarily serve as high speed, high volume traffic generators; and typically carry a wide range of users.

The intent of this Ordinance is to limit the usage of Principal Arterial and Major Collector County Trunk Highways as atv/utv road routes to reduce the potential for conflict caused by different types of users travelling at largely varying speeds in heavy volumes on the same roadway. Requests and consideration of Principal Arterial and Major Collector County Trunk Highways by atv/utv clubs shall be limited to serve the purpose of a connector between other atv/utv permitted road routes whether they be State Highways, Township Roads, Village Streets or other County Trunk Highways designated as Minor Collectors or Local Roads. Furthermore; an Arterial or Major Collector County Trunk Highway may be considered to be an atv/utv road route to provide direct access to a community (City, Village, or unincorporated Hamlet), when no other alternative route is available. It is not the intent of this ordinance for Arterial or Major Collector County Trunk Highway roads to be atv/utv road routes for the purpose of providing connectivity to all

#### SECTION 3.0: ENFORCEMENT AND PENALTIES

This ordinance shall be enforced by any officer employed by the lowa County Sheriff Department or any other law enforcement official as set forth in Wisconsin Statute § 23.33(12).

#### 3.1 PENALTIES

The penalty for violating any provision of § 2.2 of this ordinance or §§ 2.3(A) (1) or (2), (D), or (E) shall result in a forfeiture of not more than \$250.00, plus court costs.



#### SECTION 4.0: EFFECTIVE DATE

This Ordinance and subsequent amendments to it shall be effective on the date after publication. Ordinance No. 600.18B was adopted by the lowa County Board of Supervisors on July 16, 2013, and amended at the following sessions of the County Board: April 21, 2015; April 19, 2016; December 20, 2016; December 19, 2017; March 20, 2018; March 19, 2019; December 17, 2019.
