

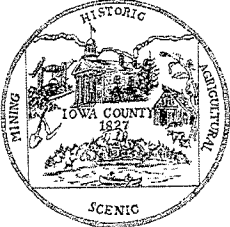
NOTICE OF AN ELECTRONIC MEETING

1	The meeting was called to order by Chr. Richter at 5:00 p.m.
2	Roll Call. Members present: Curt Peterson, Bruce Haag and Doug Richter. Others Present: Larry Bierke, Erin Hirn, and Connie Johnson
3	Approve the published agenda for this October 12, 2020 meeting. Motion by Peterson seconded by Haag to approve the agenda. Motion carried.
4	Approve the minutes of November 26, 2018 meeting. Motion by Haag seconded by Peterson to approve the minutes. Richter abstained. Motion carried
5	Report from committee members and an opportunity for members of the audience to address the committee. None.
6	Election of Chairperson: Doug Richter was the only nomination Motion by Peterson and seconded by Haag to elect Doug Richter as chairperson. Motion carried.
7	Election of Secretary: Bruce Haag was the only nomination Motion by Peterson and seconded by Richter to elect Bruce Haag as Secretary. Motion carried.
