- Brad Tucker came to look at the computers. We're waiting to hear his opinion on new computers. TC Networks can help transfer information from our old computers to our new ones and update our firewall and Wi-fi. We have a quote for \$5,757.66 from them for these services.

- Tom has talked with the Lions Club about potentially having a food stand.
- There will be parking spots blocked off for handicap access to view the fireworks.
