No action will be taken. Sup. Masters mentioned that the tree trimming / clearing project on CTH Q south of 18 was done well. Sup. Storti also brought up the SWRRTC meeting and that Highway GIS/Engineering Tech and Safety Coordinator, Kevin Peterson would be representing Iowa County. Members of the audience requested permission to speak on behalf of the Iowa County Highway Department employees regarding agenda item 9I of the Highway Commissioner's Report. Committee chair Gollon stated the Committee would hear their comments at the agenda item topic in lieu of during the public comments portion. Consider Driveway Variance for Scott Gilbertson 2500 CTH I Town of Clyde.

Commissioner Hardy presented information regarding a driveway permit submitted by Gilbertson along CTH I. After some discussion; Motion by Storti seconded by Masters to grant a Type B permit (in lieu of a type A as applied for) with a variance for stopping sight distance to the west of the drive, but with the understanding all other aspects of the drive will need to comply with the Highway Access Ordinance. In addition, the drive permit does not give him a buildable property site Type B agricultural field access only; any future construction of additional buildings will require relocation of this drive and compliance of the full ordinance for the property. The drive shall comply with all other aspects of the ordinance

	requirements. And lastly; the Highway Department shall move the "Hill Blocks View" sign at the location to the west to incorporate notice to this drive location.
