| 3 | Agenda for this 05-08-2023 meeting and minutes of the 02-14-2023 meeting were approved by unanimous consent with no revisions. No Comments from the Public. |
| 4 | Report from Committee members and audience. No public comments. Wells provided an introduction as the commission replacement to WisDOT traffic safety engineer for Schmid. Also, provided an update on the review of speed limits in the Village of Hollandale. A speed limit study would be performed if warranted, however; the location does not warrant a study at this time due to being considered the outlying district of the village. The driveways must be within a set distance criterion on both sides of the highway as measured along the CL of the roadway (STH 78). Since the criterion is not met, the speed limit change or study is not warranted at this time for the Village of Blanchardville along STH 78. |
| 5 | <p>Project updates: Chair Hardy summarized the various construction projects going to in the county and the schedules for the work:</p> <ul style="list-style-type: none"> A. STH 133 Lone Rock Bridge Road Closure Mid-June to August.. B. STH 39 Edmund – Mineral Point mill and overlay ongoing through June.. C. STH 80 Cobb – Highland mill and overlay starting early June. D. STH 14 Wisconsin River bridge to Oak Street Arena under traffic June – July. E. CTH K – USH 18/511 to CTH ID. F. CTH W Jonesdale Bridge - August. G. CTH H Culvert HN-42 at Knobs Road - August. Discussion of ATV/UTV route closures and notifications. Advised members of the Department using Rave for text messaging of culvert replacements and other work as well. H. CTH Q STH 18 – STH 80 Culvert Replacements. I. CTH T North CTH H – CTH Z Culvert Replacements. J. CTH G Lafayette County – CTH E Culvert Replacements. K. CTH T reconstruct from Wood St to CTH H was postponed until 2024. |

6	Frost – BOTS Report. Frost screen shared a powerpoint deck, which was distributed via separate email after the meeting. The powerpoint covered the metrics for accidents in the County to-date 2023. Discussion of the fatalities in the county to-date, including the recent motorcycle incident near Dodgeville. Discussion of a implement of husbandry incident in the county recently versus atv/utv crash reporting. Discussed the NITSA safe system approach; legislative bill proposal summary; community maps updates including winter road statistics, government property, and workzone related triggers; Crash Dashboard; and other county specific information and reports. Frost distributed his powerpoint information to the group post meeting via email.
7	Spot Maps report – covered by Frost in the BOTS update. Discussed some information relative to the fatalities in the county; atv/utv reporting; and community hot spot or heat map reports.
8	Other business for discussion. Durst commented on the final planning for the Iowa County dairy Breakfast which is scheduled for June 3 rd at the Cheese Plant in Arena. Discussed traffic access, logistics, and other aspects for preparations due to location on STH 14 and traffic amounts. No other business.
