7	<ul> <li>Aging &amp; Disability Resource Center &amp; County Aging Reports:         <ul> <li>a. Lafayette County – Harcus presented. Senior Farm Market still going. The Elder Benefit Specialists will be going to the meal sites, along with doing mailings to senior housing. EBS will be holding a Welcome to Medicare, it will be the last one for this year. The 5 year transportation plan was approved at full county board last Tuesday and will be submitted to the state in October. September 20 will be the Shopping News Young at Heart Expo at the Belmont Convention Center. The Public Library in Darlington will be holding memory screening September 18, 25. They will also be showing the Spark movie September 27th from 5:30-7:30 pm.</li> <li>b. lowa County – Hiltbrand presented. Senior Farm Market vouchers are available yet. Outreach events ADRC attended recently: the taxi was in the Farmers Appreciation Day parade, they were at the Night Market at the Dodgeville Town Square. ADRC will be attending the Mineral Point downtown grand re-opening on August 26 and will have a booth at the lowa County Fair. Upland Hills Health will be holding monthly presentations on the first Wednesday of the month at 6 pm. The Health &amp; Wellness Expo will be Sept 15 from 9-12 at Hidden Valley Church in Dodgeville. Meal can be reserved with SUN. They are currently recruiting an Adult Protection Services social worker with ADRC. It will be a new position as they are adding staff and clients.</li> </ul> </li> </ul>
8	HR Directors, Iowa & Lafayette Counties – SUN Director Position: Leitzinger inquired about helping to fill the SUN Director position. Iowa County Human Resources is offering assistance with the job description, timelines, recruitment, interviews and offers. Nankee asked what other surrounding county's wages look like. Leitzinger mentioned that many of the surrounding
	counties do not have a director, that they have coordinator. She noted that a dietician may be harder to hire and cost more wage-wise and that the dietician duties could be contracted out. Marion stated that she thought the professional personnel should handle filling the position, not the board. McManus

cautioned regarding contracting out for dietician, the board should keep an eye out regarding options and fees. Lafayette County Human Resources' input is desired but thus far has not contacted Leitzinger. Informational suggestions made to job description and distributed by Leitzinger. Iowa County Social Services may assist in the process as well.

Motion by Marion to receive help from the county Human Resources Departments to fine tune the recruitment, job description and hiring process of the SUN Program Director position; seconded by Richter. Aye: 6; Nay: 0. Motion carried

### 9 Monthly Reports- possible action:

- a. Cash Flow Statement & CD Review- July 2023— Report provided. Last month's board meeting they had \$29,547; today \$34,337. 2<sup>nd</sup> First National Bank CD has a better rate available at 5.12% if a change is desired.
- b. Financial Reports, Profit & Loss, Bill Pay- July; Year to Date 2023 June and July reports distributed by McManus. A list of bills paid in July also distributed. There was a 2% increase in revenue, but expenses are also up. Consumables and meal costs are up and the Numbers4Nonprofits monthly expense is about \$2500. Numbers4Nonprofits has hired a new person with expertise in fundraising and grants. This person is available to us, but unknown what additional fee might be. With the better reports from Numbers4Nonprofits, the audit fees may decrease some but not significantly. There is -\$20,000 overall income is showing January through July 2023. How to cover the deficit was posed by Mumm. \$3700 Emergency Food and Shelter grant funds coming in per McManus that will help offset the deficit. More Food share money is also coming in due to a better system now in place. Family Care reimbursements will be coming in at \$14.30 starting in August and this will be approximately an additional \$1100 coming in per month. NOAA full cost meals need to be collected or we need to discontinue services per Mumm.
- c. Monthly Participant Numbers- July 2023 Reports provided. Due to staff issues, there were no reports in July for last year to compare. Dodgeville and Mineral Point numbers are down. Lafayette remains pretty consistent. Breakfast attendance is up in Blanchardville. Summary average contribution for Lafayette \$4.51, which is slightly higher than Iowa at \$4.12. Motion by O'Brien to put these reports on file; seconded by Boyle. Aye: 6; Nay: 0. Motion carried.
- <u>County Contracts/Update</u>: Slaney cited changes in county financial package. May be funding delays in future because of new accounting system. Mumm needs full June numbers to release funding from GWAAR.

## a. Covering 2022 Deficit

Per McManus. SUN will ask for more funds from Iowa County going forward. Nankee also said accountants may have some ideas for 2023 and going forward. Mumm cited these monies can't be used for covering 2022. Per Slaney, the \$30,000 from 2022 has to be covered and auditors will likely address that. 2023 needs to close at 0 or in the black, not in the red as 2022. When the books are closed out for 2022 at end of audit, the deficit will need to be met. Per Slaney, we can wait until the audit is done and see what their recommendations are and then take action. It is important to keep separation of annual expenses.

#### b. Funding Deficit of Home Delivered Meals

Per McManus explained that the funding is less for home delivered meals than congregate. She spoke with GWAAR and all counties seem to be facing the same issue. The need will get higher for home delivered meals, it is more economical than a nursing home for participants. The prioritization for meals program is an option to reduce home delivered participants and create waiting lists. It would require more detailed assessments. Service areas could also be addressed. Mumm can provide projections for future numbers for meals vs funding. A voucher program through GWAAR is also possible. We would need to establish a relationship with a local restaurant(s), and agree on a meal price with tip. A person would be allowed 22 vouchers per month. Menu items would be pre-approved with a dietician and the restaurant. At the end of the week, the restaurant would turn in their vouchers for reimbursement. There may be less stigma

	with eating in a restaurant. The program would require extra legwork up front but once implemented, it could be a win-win for us and the restaurant(s). Voucher meals are considered congregate meals. Carry out meals are considered home delivered. These ideas need further discussion and solutions per Nankee.

	a. Dodgeville provider change – September 15, 2023 is now the new date for meals from the Law Enforcement Center. The contract was received yesterday per McManus. Dodgeville and Linden were verified and are both included. It will be \$7 per meal for 2023.
