| 5 | Consider a Variance Request by Klosterman for a Driveway Permit on CTH YZ.

Commissioner Hardy presented, Mr. Klosterman spoke. Discussion of drive location and reason for the permit. Hardy commented the owner was proposing an improvement of the drive placing a new asphalt surface on the drive which necessitated permit as the current location was grandfathered (IE no permit on file). Motion by Sup. Kreul, seconded by Sup. Leix to approve a driveway variance for a driveway at #5110 CTH YZ, whereby allowing two driveways on the one parcel with a separation distance of about 150 LF. Motion to approve a variance allowing a 2 nd drive on the parcel of #5110 (drive to the main house) which falls within the required minimum 300LF spacing distance for driveways – approved unanimously. |
