3	Consent Agenda for this 02-11-2025 meeting, the minutes of the 11-12-2024 meeting, and the dates for the 2025 commission meetings were motioned for approval by Peterson, seconded by Wells. Motion approved unanimously. The Tentative Meeting dates for 2025 were approved as: 1) Tuesday May 13, 2025 at 9:30AM. 2) Tuesday August 12, 2025 at 9:30AM. 3) Tuesday November 11, 2025 at 9:30AM. 4	Report from Committee Member sand Public Comment. No action taken. No Comments.	
5	Hardy presented a notice for spring road postings, which will be published in the next two issues of the Dodgeville Chronicle. Postings go into effect upon installation of the signage. Also, provided in the packets and posted on the County Highway Department Webpage is a pdf map of all of the posted roads in Iowa County for the spring. Some questions on posting. Discussed the different postings being on CTH's are a 12-18-24 Ton posting which is in affect a Class B 60% of the legal load posting table in statute. Blanket posting means a 10 ton posting is in affect for all roads in the township. The towns all perform a standard 10 Ton posting.	
6	BOTs Report and Spot Map Report. Horn provided a powerpoint slide deck of several items. The slide deck was emailed to all attendees after the meeting and included with the meeting minutes in the county file archives. Spot Map Report – 2024 in recap all crashes for 2024 were down when compared to the 5 year average, reductions from 10 to 24%. Fatalities dropped from 5 to 2 in the county, so overall a good trend. Reviewed the crash prediction heat map for the next 90 days, which highlighted three-four areas along USH 151. Discussed Amish buggy incidents, and slow moving vehicle signage requirements. Researched §346.0 and §347.0 discussing the SMV requirements with animal drawn vehicles and maybe some outreach could assist with those issues. Discussed a new tool for law enforcement to assist with	

	impaired driver determinations. The Governor's Safety Conference has been announced and will occur on August 19-20 2025
