1	The meeting was called to order at 9:35 AM by Chair Hardy.

3	Consent Agenda for this 05-13-2025 meeting, the minutes of the 02-11-2025 meeting, and the dates for the 2025 commission meetings were motioned for approval by Peterson, seconded by Hardy. Motion approved unanimously. The remaining Meeting dates for 2025 are: 1) Tuesday August 12, 2025 at 9:30AM. 2) Tuesday November 11, 2025 at 9:30AM. Those future meetings will be held in Room 101 of the Law Enforcement Center on Leffler street.	
4	Report from Committee Member sand Public Comment. No action taken. No Comments.	
5	On Duty Reporting for employee in-service incidents. Discussion of MV-4000 reports and on-duty reporting categories for employees involved in incidents during responding as part of their employment. Some counties have been experiencing the situation where their plowing staff are involved in an incident then their insurance companies are raising their rates for an on-duty situation. discussion of the categories on an MV4000 and how to file the forms. For county employees in Highway; statues are clear with regards to winter operations only so coverage not for other on-duty times.	
6	CTH K intersection with USH 18/151 Barneveld. Hardy reported the intersection with USH 18/151 at Barneveld and CTH K was closed permanently on Thursday May 8 th as a result of two fatalities at the intersection in the month of April. the CTH K traffic was re-routed on CTH ID, Industrial Drive, and Jones Street back to CTH K. All CTH K to USH 18/151 traffic is directed ot the CTH ID interchange.	
7 & 8	BOTs Report and Spot Map Report. Horn provided a slide deck presentation talking about crashes, data, community maps, and other indicators. The Powerpoint deck is filed with the Commission meeting minutes. The Commission reviewed the two fatalities which occurred at the USH 18-151 and CTH K intersection earlier in the month, also reviewed other traffic incidents, crash triggers, curve issues, and other matters. Reviewed other features of Community maps, discussed the MV4000 forms, and other matters. Discussed the intersection with STH 80 and CTH Q and another truck leaving the roadway at the location. the intersection is in the middle of a long horizontal curve, we discussed chevrons and other warning signage. Wells stated he would review the situation with Signing and Marking staff.	

9	Other business for discussion. Statement of construction projects starting up in the county being: a. May 8 th letting for a High-friction surface treatment project on USH 18/151. b. December letting for devices changes at Johns Street and USH 18 for 2026 construction. c. CTH YD pr-construction meeting held with a start date of this week at Bus 23 to Premiere Co-op. d. CTH K at the Pecatonica school in Hollandale project starting soon as well.
