 - **b). Budget Reports** Total Income February was \$31,782.97; Total Expense for February was \$53,924.40. Net decrease for February was \$21,141.43. YTD Income was \$147,394.64, YTD Expense \$\$99,892.93. Increase YTD \$47,501.71.
 - c). Site Numbers-Total meals served Iowa Cty February 2279. Total meals served Laf Cty February 1714. A motion was made, to file the reports, by Fisker. Seconded by O'Brien. Motion carried.
- 9. Staff/Site Issues/Reports- a) COVID Update-There is a light at the end of the tunnel. We're hoping for phase II to come about. We may be able to open more sites for Congregate meals. b.) Shullsburg Dishwasher –City of Shullsburg voted not to give any funds toward the dishwasher. We need ways to fund the additional \$3,000. Farrah suggested we use "go fund me account" in facebook. The new dishwasher should save \$1600 a year in disposable dishes and will save water. We decided to postpone the discussion until next month. c.) Schedule Evaluation of Director-It was decided to postpone the evaluation until members are able to come to attend in person.
- **10. Grants-** DUWI: we received \$700 for an electric bag and trays for Darlington. Next up is Blanchardville & Hollandale on March 15th. United Fund of Iowa County: we received \$8,000, all used for mileage and stipends for Iowa county.
- 11. Directors Report- It was discussed with Hiltbrand and Schroeder to include a survey with the April statements. The plan was to get results for building a long term aging plan. McManus recognized donations from Belmont, \$1640, Hidden Valley \$663, and more cards to be handed out from Joan Davis's classes at Dodgeville elementary school.
