- d) Jeff Lockhart presented the Agency Director's report as follows:
  - i. Unassigned funds balance is at 26% reserve.
  - ii. Act 184 Legislation passed for Sexually Violent Persons (SVP) to return to their county. The County will form a committee to identify prospective housing for the SVP person on Supervised Release. Grant County may have one SVP to place in the community.
  - iii. Act 262 Legislation includes various changes related to Substance Abuse Counselors. There will be changes in Statutes and Administrative Rules.
  - iv. Jeff Lockhart met with Ted Izydor regarding training for Licensed Professional Counselors, Licensed Marriage and Family Therapists, and Licensed Clinical Social Workers to provide AODA counseling.
  - v. Spoke with Grant County Social Services about Juvenile Court and obtaining funding for a family court as they have many clients where their addiction affects their family.
  - vi. WCHSA booklet on county statistics shows that Grant and Iowa Counties have the lowest in spending per capita.
  - vii. Unified is trying to increase the time spent with clients by staff not going to as many meetings and becoming more efficient.
  - viii. Richland and Green Counties wrote a grant to start Intensive Outpatient Treatment in those counties.

- 8. <u>SALARY ADJUSTMENT</u>: Discussion of the current statewide and nationwide shortage of prescribers (psychiatrists and APNP's), which is being reflected in increased salary rates for Psychiatric APNP's in the surrounding area. A salary increase was requested for the psychiatric APNP/CSP Clinical coordinator position, in order to bring it into line with local comparables. Unified will soon have only one prescriber, as the 2<sup>nd</sup>, part-time prescriber has taken employment elsewhere. Mel Masters <u>moved</u> to approve increasing the salary for this position to \$100 per hour as requested. Motion seconded by Mary Ellen Tredinnick and <u>passed unanimously</u>.
