Sup. Storti would like to see the County look at opportunities of developing the northern part of the County to promote for tourism and other purposes. Barry Hottmann and Jake Tarrell discussed the grant they will be applying for through the Public Service Commission (PSC) solar grant that has a total amount available of \$5,000,000 within the State. The due date is the end of July 2018. They are looking at the Health and Human Services Building at this time. They shared conceptual drawings with the Committee. They are still determining the scope and the amount of the grant the County would be applying for. They are still trying to determine the feasibility – cost/benefit analysis.
