Continued petition by Dean Dickel for a conditional use permit to allow a Commercial Livestock Operation on a 3.595-acre AB-1 Ag Bus lot in the E1/2-SE of S25-T6N-R3E in the Town of Dodgeville.

Mr. Dickel explained his manure management plan and operation specifics.

Motion by Supervisor Leix to approve with the following conditions recommended by the Town of Dodgeville:

- 1) The property owner of parcel 008-1304. A shall submit a current copy of the lease agreement allowing the cattle husbandry use of adjacent property (008-1304, 008-1301, 008-1302) to the Town of Dodgeville and Iowa County Office of Planning & Development. The property owner must notify the Iowa County Office of Planning & Development of any changes with the lease on file. If the lease is terminated at any time or not renewed, the conditional use permit will terminate.
- 2) The conditional use permit will be reviewed within two years of approval and future reviews would be at the discretion of the Town Planning Commission Chair and Town Chairman or designee. The property owners authorize the Town of Dodgeville or Iowa County Office Planning & Development to do unscheduled site visits to the property to verify compliance with the conditional use permit.
- 3) Animals will primarily be winter fed on parcel 008-1304, which is approximately 33.832 acres.
- 4) The number of allowed combined animal units on parcel 008-1304 and 008-1404..a will not exceed 40.
- 5) Fences will be installed on parcel 008-1304 for containment of the animals and on the perimeter of the drainage swale.
- 6) A permanent fence shall be installed around the well head to create a 50-foot buffer inaccessible by the contained animals.

Supervisor Leix amended his motion to include the condition that all fencing must be installed by December 1st of this year;

- 1) The maximum number of bedrooms that can be rented, meaning any room to have accommodations for sleeping, cannot exceed the size of the septic system. The current system is sized for 4 bedrooms.
- 2) The approval only applies to the existing residence or its replacement. Additional rental units will require a new approval.
- 3) The owner agrees to securing and maintaining any required State licenses, permits or approvals associated with the use.

Applicant Present: Kim and Roberta Barham Town Present: Joe Hendrickson, Charles Schriber, Gary Langfoss Director Godfrey gave the staff report Mrs. Barham clarified the proposed operation as follows: 1) The scale of the U-pick operation is to be at most 25-30 people over a 3-day period. The season will be August through September and not involve the use of greenhouses. 2) The rental will be a single bedroom above the garage. The two bedrooms in the house will not be rented. 3) State licenses/approval have been secured for the rental. 4) The farm tours and education classes are intended to be for the benefit of groups interested in specific native plants, land management, conservation, etc. There will be no more than 75 participants at any one time and portable toilets will be rented for large groups.
