3	Approve the agenda for this January 3, 2019 meeting. Motion by Joe Witmer, seconded by Matt Allen to approve the January 3, 2019 agenda. Motion Carried.

6	Economic Development - Structure Grant Applications. Steve Genoway, City of Dodgeville Economic Development Specialist discussed the two structure grant applications for the City of Dodgeville.			
	The first structure grant request is \$10,000 to supporting the cost of professional services to plan development of 74 acres of City-owned land for economic development. The product will result in tools to help market the land to developers and businesses as well as to help the City plan infrastructure needs in the area. If the City does not move forward with these professional services, the City will refund any award in full. The \$10,000 would be approximately 83% of the cost of the project. About 20 to 30 acres is in the TIF district and is zoned limited industrial and the remaining acres is outside the TIF district.			
	Motion by Joe Witmer seconded by Matt Allen to approve the \$10,000 structure grant request supporting the cost of professional services to plan development of 74 acres of City owned land for economic development. Motion Carried.			
	The second structure grant request is \$10,000 for enhancing the reach and duration of 2019 marketing efforts for the City of Dodgeville to potential new residents, businesses seeking to take advantage of Cityowned land for economic development, and businesses seeking to start or expand in the City of Dodgeville. The funds will be used for professional content development and add to broadcasting and hosting of the content. This would supplement the \$25,000 marketing budget provided by the City of Dodgeville for a total amount available for marketing of \$35,000.			
	Motion by Nancy Smith seconded by Joe Witmer to approve the \$10,000 structure grant request for enhancing the reach and duration of 2019 marketing efforts for the City of Dodgeville to potential new residents, businesses seeking to take advantage of City-owned land for economic development, and businesses seeking to start or expand in the City of Dodgeville. Motion Carried.
