5	Continued petition by Richard Peck to rezone 3.29 acres from A-1 Ag & B-2 Hwy Bus to all B-2 Hwy Bus & 36.71 acres from A-1 Ag to C-1 Conservancy in the NE/NW & 10 acres from A-1 Ag to AB-1 Ag Bus in the NW/NE all in S22-T8N-R4E in the Town of Arena. Applicant Present: Richard Peck Town Present: David Lucey and Bill Gauger Director Godfrey gave the staff report Mr. Lucey explained there were two meetings at the Town of Arena level where concerns of the neighbors were discussed, such as pedestrian safety, parking in right-of-ways, burning of plastics, trash pick-up, and trash dumpster location. Public comment: • Lauren Rosenthal stated her concerns over the location of the dumpster, burning of animal carcasses, burning of plastics and other refuse • Edie Benusa stated her concern where parking will be allowed Supervisor Gollon stated it is not legal under State law to burn plastics or for a business to burn building materials, cardboard, etc., Mr. Lucey offered the recycling center at the Town Hall.	

Motion by Supervisor Deal to approve the zoning changes with the condition that the associated certified survey map is duly recorded within six months of the County Board approving the change; Second by Supervisor Gollon Motion carries unanimously

Continued petition by Richard Peck for a conditional use permit to allow a farm market, petting zoo, craft fairs, deer farm, and hay rides on a 3.29-acre B-2 Hwy Bus lot in the NE/NW and agritainment on a 10-acre AB-1 Ag Bus lot in the NW/NE all in S22-T8N-R4E in the Town of Arena.

Motion by Supervisor Deal to approve as follows:

- 1. The enlarged B-2 lot approved uses include a deer farm, petting zoo, hay rides, brat stand, farm market, equipment storage and craft fair with the following conditions:
 - The deer farm must comply with all State licensing requirements
 - No parking is allowed within a public right-of-way
 - The County shall have the authority to require portable toilets if a planned event may exceed the capacity of the onsite septic system
 - The associated certified survey map is duly recorded within six months of the County Board approving the change
 - A crosswalk is required over Peck Rd to the Town's satisfaction
 - There shall be contracted garbage collection
 - There shall be a dumpster with a lid
 - There shall be no burning of plastics
- 2. The AB-1 lot approved uses include a corn maze, hay rides, sleigh rides, on-farm tours and haunted farm

 jurisdiction within the Village where the current ordinance does not; stated there is no
 mandate for the County to adopt an airport zoning ordinance; stated concern over the impact
 on prohibiting telecommunication towers; stated concern over a permit being required for all
 development within the Village; stated her dislike of the mapping; and asked if there are
 standards for smoke or dust as referenced within the ordinance
- Village of Linden President Tom Faull stated his opposition to the ordinance applying within the Village
- Village of Linden resident John Trace stated his concern over how this will be administered
- Supervisor Mel Masters asked if this should go back to the Airport Commission for further consideration, of which he is a member
