 - i. Current unassigned fund balance is at 23%.
 - ii. Erin Spadafore, new hire in the Community Support Program is working well in the program.
 - iii. Unified Community Services will be sending out a reminder to jails in regards to the MAT (Medication assisted treatment) grant from the State of Wisconsin. This grant will cover the cost of an injection 5 days prior to release from jail.
 - iv. In the past Substance Abuse groups were primarily based on the 12 Step program. In Addition, they now offer Smart Recovery or weekly Mindfulness Groups.
 - v. January 30, 2019 we will be combining Mental Health and AODA programs. Mental Health, AODA, CSP and ES will be under one Behavioral Health unit. Ted Izydor has been involved with training mental health clinicians to be dually trained for AODA. The combining of departments was necessary due to stricter confidentiality laws under AODA and to provide better treatment for dually diagnosed clients.
