5)	Two members of the public addressed the committee. Margaret Peat and Shirla Gehrke are dissatisfied with the reduced Care A Van bus schedule. It was reduced from five days a week to three. They would also like to go to other places such as The Walker House in Mineral Point, Janesville, and Portage. Peat would like more advertising done since two people from the township of Clyde had never heard of the Care A Van. Peat also suggested the Care A Van schedule should include townships as pick-up points. Slaney thanked Peat and Gehrke for their comments and suggestions. Reminded all this is a work-in-progress. The ADRC is still advertising for a Rural Taxi Driver and schedules may change once that program evolves. Unfortunately, we won't be able to satisfy everyone, but our goal is to satisfy the majority. Hodan Center gave notice last month that they will no longer be a meal provider for Mineral Point. McManus has been calling local restaurants to see if they would be a provider. So far there is no interest. The Board suggested churches and long-term care facilities. McManus will investigate further. Currently, there are 10-12 meals delivered daily. SUN received a donation from Alliant Energy due to the volunteer hours Rod Lukes has undertaken. The Village of Ridgeway and Mineral Point VFW Auxiliary also provided donations. **I&A** (**Information & Assistance**): Report provided. Review **EBS** (Elder Benefit Specialist): Report provided. Stacey Terrill presented and Department distributed a flyer for the upcoming Aging Advocacy Day at the state capitol on May Reports 14. She urged the board members to please consider attending. She questioned the Reclassification of the ADRC/Social Services Business Manager position to a Grade L on the Compensation Grid. Hiltbrand hopes to have someone in May. ADRC Taxi has, on average, 18 people riding each day. Presented by Agrace Hospice & Palliative Care and assisted by the Caregiver Coalition of Iowa County. It was one of the ADRCs Aging Goals. • May 7, 2019 there will be a Volunteer Open House at the Health & Human Services Center from 3-6 p.m. Please let your friends and family know. Volunteer opportunities with the ADRC, SUN, UW Extension, Social Services, and Bloomfield Healthcare & Rehab. A four county collaborative by Grant, Green, Iowa, and Lafayette has been formed to standardize policies and procedures of Adult Protective Service Units in these four counties. Green County Adult Protective Services and Pleasant View Nursing Home, Monroe, WI have taken the lead to apply for a grant to create a 6 bed dementia crisis stabilization unit. The grant will provide for facility modifications, increased staffing and crisis stabilization training.
