## Comments from the public:

• Sup. Leix stated that he was disappointed in the County Administrator's July 3<sup>rd</sup> report that the county did not sign on with the Driftless Area Land Conservancy when they offered the county the opportunity to "piggyback" with their intervention filing with the Public Service Commission. He also questioned what authority the County Administrator had to decline the DALC's offer as the Board had voted to intervene in opposition to the Cardinal Hickory Creek Transmission Line and Matt Allen had filed the county as an intervener and stated we might sign on with another intervener.
