1	Chair Meek called the meeting to order at 5:30 p.m.
2	Roll Call. Members present: Supervisors Forbes, Haag, Meek, Ray (5:50pm) and Richter. - Others Present: County Administrator Larry Bierke, Supervisor Nankee, Supervisor Deal, Sheriff Steve Michek, Child Support Director Deb Rosenthal, and Emergency Management Director Keith Hurlbert.
3	Haag <u>moved</u> , Forbes seconded to approve the agenda June 4, 2019 meeting. Motion carried.
4	Forbes moved, Haag seconded to approve the minutes of the October 2, 2018 meeting. Motion carried.
5	Public Comments: None
6	2018 Child Support Annual Report – The Child Support Director went over her annual report. In 2018 the Department generated more revenue than expenses. The Director answered questions from the Committee.
7	Child Support Certificate of Excellence: The Child Support Department received a Certificate of Excellence for their 2018 performance. The State measures Department performance in four separate ways. Haag <u>moved</u> , Richter seconded to forward the Certificate to the County Board. Motion carried.
8	Child Support Background Check Policy: Richter <u>moved</u> , Haag seconded to recommend the policy to the Iowa County Board. Motion carried.
9	Emergency Management Report: The Emergency Management Director reported that the department recently completed an active shooter exercise at the Highland School District. Other school districts are also getting lined up. Committee members asked questions of the Emergency Management Director. The Director further reported on a new storm prediction software the department is using called "Storm Live GPS" and that the local hospital worked off of their generator over the weekend as a planned outage.
	The Emergency Management Director was also nominated to serve as President of WEMA. The Committee offered their support and encouragement.
10	Sheriff's Department Update/Report: The Sheriff reported that the Jail Building Committee was moving forward nicely and that the staff team was also spending a lot of time looking at efficiencies in the planning. Road Construction routes have been a challenge and that the Drug Task Force recently received a grant for computer upgrades.
	Employment Openings in both the Jail and the Sheriff's Office. There are two female Dispatch/Corrections Officers in the hiring process right now. A new Administrative Assistant recently started.
11	Financial Reports: The Committee reviewed the financial reports from last quarter and did not have any questions.
