	Motion to deny the zoning change by Supervisor Deal based on the inconsistencies with the Town of Brigham Comprehensive Plan Second by Supervisor Leix Supervisor Gollon stated this may be a hard action to defend given both the A-1 and AB-1 districts are Farmland Preservation Districts with similar allowed uses and nonmetallic mining is considered an agricultural use by Ch. 95 WI Stats Supervisor Deal offered a friendly amendment to his motion to include requesting legal counsel review prior to forwarding to the County Board; Supervisor Leix agreed to the friendly amendment Motion carries with Supervisors Peterson and Gollon opposing
