Gratitude was expressed from the board for all the efforts sales people put into making the 2020 Hidden Valleys guide happen. It was noted that ads for the mobile app can be sold anytime of the year. A sales meeting may occur in January for more discussion and ideas for the sales team.

Steve made a suggestion for Hidden Valleys to invest in Constant Contact to have an e-newsletter sent to all advertisers. Articles could include feedback from trade shows, visitor stories, or advertiser's highlights. This will be placed on January agenda.
