4	Sup. Butteris moved to approve the agenda for this meeting, minutes of previous meeting and next meeting for Monday June 1, 2020 at 5:00PM. Sup. Masters seconded the motion. Approved unanimously.
5	Commissioner Hardy reviewed the surface transportation projects for 2020. Projects that are currently in the queue include:

	B. STP-Rural Project Award for CTH F STH 39 to STH 78.
	C. STP-Bridge Project Award for CTH W and in the Low Risk Pilot Program.
	D. 2020 STP-Bridge construction projects for CTH HH, CTH Y, and Survey Road.
	E. STP-Bridge Project for CTH H and II.
6	First Quarter 2020 Financial Reports were presented. Some discussion by committee regarding he amounts of budget funding and the agreement for the Tri-County airport. Commissioner Hardy addressed the Iowa County Airport and Highway Department.
7	Highway Commissioner's Report: Commissioner Hardy presented the bid opening results for the Loader Bids/Lease, Tandem Axle Truck, Roof Repairs, and mowers.
	The Commissioner also addressed the Covid-19 Highway Department operations, the handling of closing state parks/facilities and closing of roads (there is no current policy), recent accident involving highway department employee and equipment and additional discretionary funding available from the State. The commissioner also discussed the ROW maintenance regarding CTH BB interchange. Hardy also addressed the number of culverts in the process of being replaced along with other upcoming unexpected culvert expenses. The Wisconsin County Highway Association June summer road school has been canceled and rescheduled for August.
